In the north west of Australia all homes are built to a very high cyclone standard, steel framed houses, windows are all cyclone rated and yet we seem to pay for

the east coast that still build timber framed homes and have very few standards. I think this needs to be taken into account when insurers consider the risk. It costs us a lot more money to build in the north west than in the rest of Australia and then we have to pay exorbitant insurance premiums.

15. What are insurers doing to make it easier and could they do more?
