Dark Fibre Record-Keeping and Reporting Rules

Issued under section 151BU of the Competition and Consumer Act 2010

February 2019

1. TITLE

(1) These Rules, made by the Australian Competition and Consumer Commission (ACCC) under section 151BU of the *Competition and Consumer Act 2010*, may be referred to as the Dark Fibre Record-Keeping and Reporting Rules.

2. COMMENCEMENT

(1) These Rules will take effect on the date they are published by the Commission on its website.

Note: The Commission will issue the Rules by making a public announcement and placing the Rules on its website

3. INTERPRETATION

AAPT means AAPT Limited (ABN 22 052 082 416)

Access Seeker has the same meaning as in section 152AG of the Act.

Act means the *Competition and Consumer Act 2010*.

Commission means the Australian Competition and Consumer Commission.

Dark Fibre An unlit strand of optical fibre that is terminated at each end on

an Optical Distribution Frame (ODF), located at the Service

Provider's Points of Interconnect (POIs).

Link means part of an optical fibre communications system which

provides a data connection between two points (point-to-point

connection).

List price means the price at which a product is sold to a customer in the

wholesale market.

NBN means National Broadband Network.

NBN Co means NBN Co Limited (ACN 136 533 741).

Nextgen means Nextgen Pty Limited (ABN 52 143 407 621).

ODF An Optical Distribution Frame (ODF) is a frame used to

provide cable interconnections between communications

facilities.

POI A Point of Interconnection (POI) is the inter-network location

where end-user traffic is handed over from the NBN onto an Access Seekers' own network or onto an Access Provider's network for transport to the retail service provider's point of

presence.

POP A Point of Presence (POP) is a point or network interface at

which a service provider hands off its service to the end-user.

Reference Date means the last day of a calendar quarter (i.e. 31 March,

30 June, 30 September, 31 December) for a Reporting Period

ending on that date.

Reporting means a service provider to which these Rules apply,

Service provider to the extent it is required to report.

Reporting Period means the last day of a calendar quarter (i.e. 31 March, 30 June,

30 September, 31 December).

Rules means the Dark Fibre Record-Keeping and Reporting Rules.

Superloop means Superloop (Australia) Pty Limited (ABN 86 602 286

4. APPLICATION

(1) These Rules apply to:

(2) These Rules also apply to a service provider that supplies dark fibre and has been provided no less than two months' notice in writing by the Commission that the Rules apply to that service provider. The Commission must specify, in the written notice, the categories of information prescribed in **Schedule A** that will apply to the service provider. The written notice must be published on the Commission's website.

5. RECORD KEEPING

- (1) Service providers listed in Paragraph 4(1), or to which Paragraph 4(2) applies, must keep and retain the records prescribed in **Schedule A**.
- (2) The information that must be contained in the records kept in accordance with **Schedule A**, and the manner and form in which it is to be kept, is specified in **Schedules B and C**.

6. REPORTING REQUIREMENTS

- (1) A service provider must provide to the Commission for each Reporting Period a report that consists of the information required to be kept under Rule 5.
- (2) A report must be lodged with the Commission by within 60 calendar days of the Reference Date of each quarterly Reporting Period.
- (3) A report must be prepared and submitted electronically in a Microsoft Excel format, or as otherwise specified on the Commission's website.
- (4) A report must be provided to the Commission by email to <u>DarkFibreAggregationServices@accc.gov.au</u>, or as otherwise specified on the Commission's website.
- (5) The format referred to in **Schedule D** may be amended by the Executive General Manager of the Infrastructure Regulation Division from time to time.
- (6) The ACCC must provide the service providers listed in Paragraph 4(1), or to which Paragraph 4(2) applies, with written notice of any amendment under sub-rule (5) and published on the Commission's website.

Schedule B

Dark fibre information to be reported by service providers supplying dark fibre to NBN POIs

- (1) For each Reporting Period, the service providers listed in Category (1) of <u>Schedule A</u> must provide to the Commission the information set out in paragraph (2) below, in accordance with the template set out in section 1 of **Schedule D**.
- (2) For service providers currently supplying dark fibre to NBN POIs, the service provider must state:
 - (a) The specific NBN POIs (by POI name and state or territory in which the POI is located) at which dark fibre is owned by the provider as at the Reference Date.
 - (b) The name of each Access Seeker being supplied dark fibre as at the Reference Date.
 - (c) For each Access Seeker in (b) as at the Reference Date:
 - a. the number of Links supplied
 - b. the distance of each Link
 - c. the NBN POI at which the Links are terminated.
 - (d) The prices charged (\$AUD) for each Link in (b) and (c) for the Reporting Period.
 - (e) Any wholesale List prices for each Link in (a) as at the Reference Date.

Schedule C

Dark fibre information to be reported by service providers with dark fibre connected, or able to be connected, to NBN POIs, but not currently supplying services using that dark fibre to third parties

- (1) For each Reporting Period, the service providers listed in Category (2) of <u>Schedule A</u> must provide to the Commission the information set out in paragraph (2) below, in accordance with the template set out in section 2 of <u>Schedule D</u>.
- (2) For service providers with dark fibre connected, or able to be connected, to NBN POIs, but not currently supplying services using that dark fibre to third parties, the service provider must state:
 - a. The specific NBN POIs (by POI name and state or territory in which the POI is located) at which dark fibre is available as at the Reference Date.
- (3) For each POI in 2(a) as at the Reference Date:
 - a. the number of Links owned
 - b. the distance of each Link
 - c. the NBN POI at which the Links are terminated.
- (4) Any wholesale List prices, for the Links listed in (3) as at the reference date.
