In 1999 cyclone Vance pumpled Exmouth. We were insured with SGIO, they sent in assessors that were less than compassionate and were clearly trying to save the insurance companies as much as they could. Examples were "we could rip our carpet up and hang them out to dry" the whole house. we lost six walls and a ceiling in our house. They would replace the damaged materials but tried to get out of painting all the walls in some areas. Our house was only 3 months old. We actually put in a complaint about the bloke and as I understand he was rightly fired.
