I write to you in relation to the attached correspondence from the Hon Angus Taylor MP, Minister for Industry, Energy and Emissions Reduction, and the Hon Keith Pitt MP, Minister for Resources and Water.

The Ministers' letter notes the recent decision by Incitec Pivot Limited to close its Gibson Island manufacturing plant from December 2022, which Incitec Pivot Limited has attributed to a claimed inability to secure a commercially viable long-term gas supply arrangement.

I request that the ACCC consider the matters raised by the Ministers' letter, as appropriate, to the extent permitted by former Treasurer's direction under subsection 95H(1) of the *Competition and Consumer Act 2010*, which established the Gas Inquiry 2017-2025.

I have copied this letter to the Hon Scott Morrison MP, Prime Minister, the Hon Angus Taylor MP, Minister for Industry, Energy and Emissions Reduction, and the Hon Keith Pitt MP, Minister for Resources and Water.

Dear Treasurer

We are writing to request you provide further direction to the Australian Competition and Consumer Commission (ACCC) on its *Gas Inquiry 2017-25*.

As you may be aware, on 8 November 2021 Incitec Pivot Limited (IPL) announced the closure of its Gibson Island fertiliser manufacturing plant. IPL attributed the closure, effective from December 2022, to its inability to secure an economically viable long-term gas supply arrangement.

As we continue to implement the Gas-Fired Recovery, it would be useful for us to understand in more detail the circumstances that led to IPL's decision to close Gibson Island.

Accordingly, we ask you to direct the ACCC to examine in detail the gas tender process IPL conducted for Gibson Island prior to the closure announcement. We ask this examination include correspondence between gas producers and IPL while noting that due to the constraints within the *Competition and Consumer Act 2010*, the ACCC can only examine this from producer responses to and/or about the tender.

We understand the *Gas Inquiry*'s timelines and information gathering processes means that the ACCC findings about behaviours related to the tender response will likely be published in the thirteenth interim report.
