ACCC - What It Is

- Based on Trade Practices Act
- Promotes Competition & Consumer Protection
 - Through Fair & Informed Markets
- Widest Definition of "Consumers"
 - Household
 - Small, Medium & Big Business
 - Farmers
 - All Levels of Government
- If Buying Being Supplied Competitively & Efficiently
- If Selling Have Buyers Who Compete
- Expanded ACCC Role
 - Past Decade
 - New Law
 - Merger of TPC & PSA

ACCC - What It Covers

- Two Edged Sword
 - Benefits/Protection
 - Obligations



- Multi Pronged
 - Restrictive Trade Practices
 - Anti Competitive Structures
 - Unconscionable Conduct
 - Misleading or Deceptive Conduct
 - Regulation of Utility Sector Access
 & Pricing
- Competitive Implications
 - Level Playing Field
- TPA Link to Other Legislation
 - Price Surveillance
 - State Regimes

ACCC - How It Works

- Dual Role
 - Investigation / Enforcement
 - Compliance Through Education & Information
- Structure of Operation
- Alternatives to Court Action
 - Administrative Settlement
 - Undertakings (examples)
- Importance of Legal Determination
 - Clear Statement From Court
 - Publicity Important for Compliance
- Examples
 - Boral
 - Credit Card Fees

- Positive Court Outcomes
 - Retail Tenancy Cases

- Level of Complaints Stabilising
- Strengthening Remedies
 - Quick Administrative Response
 - Further TPA Amendments June 2001

New Tax System Pricing

- ACCC Major Role
 - Strong Laws
 - Compliance Challenge
 - Significant Transition Process
 - Generally Excellent Compliance
 - Relatively Smooth Outcome
 - Avoided Price Spiral Effect
 - Chaos Would Have Harmed Small Business
- Dispelling Myths
 - No Price "Freeze"
 - Inadvertent Mistakes
 - Use of Publicity
- Some Emerging Problems
 - GST Inclusive Price Quotations
 - False Collection of GST
