## Variations to Telstra's Migration Plan

I enclose for your consideration Telstra's proposed variations to the Migration Plan. Telstra requests approval from the Australian Competition and Consumer Commission (ACCC) for the enclosed variations to the Migration Plan as allowed under section 577BF of the Telecommunications Act 1997 (Cth).

As discussed with the ACCC, the proposed variations to the Migration Plan relate to facilitating the rollout of Fibre to the Curb (FTTC) as an access technology by NBN Co, as part of its Multi Technology Mix platform. Our variation also includes some minor amendments to the duration of the Order Stability Period, and clarification about the application of cease sale restriction to Muti Dwelling Unit (MDU) Common Area Sub Locations (CASLs). We note that NBN Co approves of the proposed variations.



A detailed supporting public submission on our Varied Migration Plan is enclosed to describe and explain the amendments to the Varied Migration Plan. In addition to the preliminary briefing we have already provided to you, we would be happy to provide any further explanations the ACCC would find to be of assistance.

Our Varied Migration Plan is provided to you in both 'clean' and 'marked up' versions to assist with your review and consultation process. The 'marked up' version shows all changes made from the current Migration Plan (as approved by the ACCC on 20 July 2016).

In addition we note that the Migration Plan we are submitting for approval is a consolidated version, which incorporates into both the 'clean' and 'marked up' versions the previously approved Schedule 1 and Required Measures 5(A) to (E) (inserted into Schedule 7). The incorporation of this previously approved content has not been marked up in either version.
