### **Progress of APS Reform**

Across the Australian Public Service (APS), changes are happening to make our public service stronger.

The changes will ensure the services we deliver and the policies we design are future APSREFORM fit and will support Australians for decades to come.



APS Reform is the government's plan to build trust and integrity, put people and business at the centre, create a model workplace, and build the skills and capability we need for the future.

At the ACCC/AER, we're tracking these reforms closely. Some of the actions we've been taking over recent years are ahead of the curve, meaning we have a head start. Other reforms are aligned with the direction we've been taking, but will require some additional shifts and steps up.

Our People and Culture team will be leading this additional work if it relates to people reforms, and collaborating with other functions across the agency for the other reforms.

We'll be discussing these at various forums, including the ACCC Senior Management Conference in 2024.

#### About APS Reform

In October 2022, the Australian Government announced its APS Reform agenda to deliver enduring change to strengthen the APS for the benefit of all Australians.

The Reform Agenda is underpinned by 4 priorities:

- 1. An APS that embodies integrity in everything it does
- 2. An APS that puts people and business at the centre of policy and services
- 3. An APS that is a model employer
- 4. An APS that has the capability to do its job well.

APS Reform aims to strengthen and empower the public service and increase trust and confidence in Australia's public sector institutions.

It builds on previous reform efforts and supports the APS to be future fit and capable of adapting and evolving to changing and rising expectations.

APS Reform is a service-wide undertaking. Forty-four current APS Reform initiatives are being implemented across the service, led by 12 departments and agencies.

The APS Reform Office and the Australian Public Service Commission work closely with the Secretaries Board, Department of the Prime Minister and Cabinet, Department of Finance, Attorney-General's Department and other agencies to deliver APS Reform.

The first stage of APS Reform focusses on enabling measures that support the foundations for enduring reform.

The second stage of APS Reform builds on these activities to bolster integrity, create an outward facing APS and further strengthen capability.
