Council Solutions application for authorisation AA1000420 (ancillary service streams) - interested party consultation

The Australian Competition and Consumer Commission (the ACCC) is currently conducting a consultation process on an application for authorisation received from Council Solutions on 04 May 2018.

The purpose of this letter is to invite you, as a potentially interested party, to comment on the application. Please see the ACCC's publication <u>Authorisation process - the basics</u> for a summary of the authorisation process and how to make a submission to the ACCC.

Application for authorisation

Council Solutions, on behalf of the Cities of Adelaide, Charles Sturt, Marion and Port Adelaide Enfield (Participating Councils), is seeking authorisation to jointly procure the collection of ancillary waste services, comprising the:

- multi-unit collection of Bulk Bins and processing or disposal of the waste (including the supply and maintenance of the bins)
- kerbside collection and processing or disposal of Hard Waste and
- collection of park and footpath litter and/or recycling bins and disposal or processing of the waste.

This application for authorisation is for ancillary service streams only.

Council Solutions has lodged further applications for separate request for tenders for collection services streams and for processing service streams. The ACCC is running separate public consultation processes in relation to these applications.

Request for submissions

The ACCC invites you to make a submission on the likely public benefits and effect on competition, or any other public detriment, from the proposed arrangement.

If you intend to provide a submission in relation to the application for authorisation, please do so by 6 June 2018. Submissions should be emailed to adjudication@accc.gov.au with the subject "AA1000420 - Council Solutions - submission".

Submissions, including oral submissions, will be placed on the ACCC's public register subject to any request for exclusion. Please indicate clearly in your submission whether you are content for the ACCC to place it on our public register; or are requesting exclusion (with brief reasons). For more information, please see the ACCC's publication <u>Guidelines for excluding information from the public register</u>.
