# Racing and Wagering Western Australia application for minor variation of Authorisation AA1000423—interested party consultation

The Australian Competition and Consumer Commission (**the ACCC**) has received an application from Racing and Wagering Western Australia (**RWWA**) for a minor variation of Authorisation AA1000423. The ACCC invites you to comment on the application. Attached is a summary of the authorisation process including how to make a submission to the ACCC.

Authorisation AA1000423 was granted by the ACCC on 31 August 2018 allowing RWWA to give effect to a management services agreement governing the provision of fixed odds wagering and risk management services until the expiration of that agreement on 30 December 2028.

## Proposed minor variation to AA1000423

RWWA has applied for a minor variation of the authorisation in anticipation of the sale by the Western Australian Government of the wagering business conducted by RWWA. The changes relate to the current relationship between RWWA and TSG Wagering/BetEasy, including a reduction in fees and provisions relating to the platform used to provide services to RWWA (such as how outages are dealt with).

Importantly, the ACCC notes that the terms of the minor variation sought would not cover any post-sale relationship between the purchaser and TSG Wagering/BetEasy.

The ACCC invites you to make a submission on the likely public benefits and effect on competition, or any other public detriment, from the proposed variation.

Submissions, including oral submissions, will be placed on the ACCC's public register subject to any request for exclusion.
