## Dear Ellie.

In reference to your queries regarding the figures supplied for the collected and processed tonnages for the 5 councils supplied in Table 9 and paragraph 11.70;

- The figures in Table 9 are derived from projected data supplied by each of the councils at the time the application was prepared. This figure is considered correct based on information available at the time.
- The figures quoted at 11.70 should read " Of a total 1,938,483 tonnes of Waste material collected by the councils in the SMA, the Applicants represent 239,991 tonnes or about 12.4% of the total market for all waste processed in the SMA". This data is supplied from the NSW EPA Annual Data Report from 14/15, which is the most current EPA published report available. This report collects data from all councils in NSW and therefore in order to calculate the percentage of the market share that the five councils represent within the SMA, this is the most recent and appropriate data that can be relied upon. Whilst the exact figure cited for waste tonnage processed at 11.70, being 112,380 tonnes is yet to be reconciled, a review of EPA data cited in their report does substantiate the broad statement that the market share across the five Councils does equate to approximately 12% of the SMA.

I trust clarifies the discrepancy and should you require further assistance please let me know.

Thank you for returning my call this afternoon.

As mentioned, we have noticed a discrepancy in the application regarding the FY17 collected and processed tonnages for the five councils:

- At Table 9 of the application, it states that the total FY17 collected and processed waste tonnages is 231,970
- At paragraph 11.70, it states that the Applicants currently represent approximately 112,380 tonnes or about 12% of the total market for all waste processed in the SMA.
