The Recruitment, Consulting & Staffing Association Limited (RCSA) application for revocation of authorisation A91388 and substitution of new authorisation AA1000435 – interested party consultation

The Australian Competition and Consumer Commission (the ACCC) is currently conducting a consultation process on an application for revocation and substitution received from RCSA on 6 February 2019.

RCSA seeks revocation of authorisation for its Professional Conduct Regime, which RCSA currently administers through its *Code of Professional Conduct*, *Disciplinary and Dispute Resolution Procedures* and relevant clauses of the RCSA Constitution and By Laws.

The proposed substitution includes a new version of RCSA's code (the *Code for Professional Conduct*) and the new *Professional Conduct Grievance Intervention Guidelines* as well as relevant clauses of the RCSA Constitution and By-Laws.

RCSA seeks authorisation for a period of 10 years. For the initial 12 months of this period, the Code present in RCSA's most recent authorisation would apply, with the new Code then authorised for the 9 years following this initial 12 month period.

The ACCC has granted authorisation on three separate occasions to RCSA for similar conduct. Each authorisation was for a period of five years. RCSA's most recent authorisation commenced on 12 February 2014 and expires on 6 March 2019.

Interim authorisation

RCSA has requested interim authorisation as the ACCC is unable to make a final determination on RCSA's application for revocation and substitution before RCSA's existing authorisation expires on 6 March 2019.

RCSA applies for interim authorisation to continue to use elements of its currently authorised Professional Conduct Regime, which includes:

- The current Code of Professional Conduct
- Relevant clauses of RCSA's Constitution and By-Laws.

Interim authorisation is also proposed to include the new *Professional Conduct Grievance Intervention Guidelines*, which is not included under the current authorisation. The ACCC decides whether to grant interim authorisation on a case by case basis. Should an applicant request interim authorisation, the ACCC will usually consider a range of factors, including:

- · harm to the applicant and other parties if interim is or is not granted
- possible benefit and detriment to the public of granting interim authorisation
- the urgency of the matter
- whether the market would be able to return to substantially its pre-interim state if the ACCC should later deny authorisation.

Request for submissions

The ACCC invites you to make a submission on the likely public benefits and effect on competition, or any other public detriment, from the proposed arrangements.

If you intend to provide a submission in relation to RCSA's **request for interim authorisation** please do so no later than **19 February 2019.**

Submissions on the substantive application for revocation and substitution of authorisation should be provided by 13 March 2019.

Submissions, including oral submissions, will be placed on the ACCC's public register subject to any request for exclusion. Please see the ACCC's publication <u>Guidelines for</u> excluding information from the public register.
