The Australian National Kennel Council Limited (**ANKC**) is the peak body in Australia responsible for promoting breeding, showing, trialling, obedience and other canine-related activities and the ownership of purebred dogs in Australia. ANKC functions as a co-ordinating body between the peak canine bodies in each state and territory, who in turn has the responsibility of interacting with the public in their state or territory on canine-related activities and the ownership of purebred dogs. These peak canine bodies in each state and territory are members (**ANKC Member Bodies**) of ANKC.

One of the functions of the ANKC is to set and manage regulations to be complied with by ANKC Member Bodies. Amongst other objectives, these regulations are implemented with the primary goal of ensuring the health and welfare of dogs in Australia. One such regulation is the National Code of Ethics of Responsible Dog Ownership. The ANKC Member Bodies are required to give effect to that regulation made by ANKC (and other regulations where applicable) within its jurisdiction in order to regulate the conduct of individuals who are members of those ANKC Member Bodies in their respective jurisdictions.

1. Executive Summary

The Australian National Kennel Council Limited (**ANKC**) is the peak body in Australia responsible for canine-related activities and the ownership of purebred dogs in Australia. ANKC functions as a co-ordinating body between the peak canine bodies in each state and territory. These peak canine bodies in each state and territory are members of ANKC (**ANKC Member Bodies**).

ANKC mandates a standard of conduct relating to dog ownership under its National Code of Ethics of Responsible Dog Ownership (Code of Ethics). It is required to be implemented by each ANKC Member Body in their respective states and territories. Only breeders and dog owners that are registered as members of ANKC Member Bodies (ANKC Registered Breeders and Owners) are, in turn, required to comply with the Code of Ethics.

Authorisation is sought in respect of a proposed arrangement to insert a new provision in the Code of Ethics to require ANKC Registered Breeders and Owners to register puppies with canine registration bodies which are recognised by the ANKC (**Proposed Amendment**). The recognised canine registration bodies consist of the ANKC Member Bodies and other overseas canine organisations specified in paragraph 6.2 of these submissions.

The rationale for the Proposed Amendment is to improve the health and welfare of dogs and to minimise conduct that may mislead, deceive or, at the very least, confuse the public that dogs marketed as "registered" are not in fact registered with an ANKC Member Body or a body recognised by ANKC.

ANKC submits that, the Proposed Amendment has, or is likely to have, minimal detriment to the Australian market for Registration services. ANKC further submits that the Proposed Amendment would result, or be likely to result, in a benefit to the public that outweighs any detriments that will or likely to result. In particular, as further detailed in Section 7.1, ANKC estimates that in 2016 only 15% of all puppies were bred by breeders registered as members of ANKC Member Bodies.

2. Introduction

2.1 Application for authorisation

The Australian National Kennel Council Limited (**ANKC**) makes this submission in support of its application for authorisation pursuant to section 88(1) of the *Competition and Consumer Act 2010* (Cth) (**CCA**).

Authorisation is sought in respect of a proposed arrangement (as further described in section 4 below) which might be regarded as contravening sections 45AD, 45 and 47 of the CCA. Although, in ANKC's view, the proposed arrangement does not contravene the provisions of the CCA, it wishes to seek certainty and protection afforded by an authorisation prior to undertaking the proposed arrangement.

ANKC submits that, in all the circumstances, the proposed arrangement:

(a) would not have the effect, or would not be likely to have the effect, of substantially lessening competition; and



(b) would result, or be likely to result, in a benefit to the public and that benefit would outweigh the detriment to the public that would result, or be likely to result, from the proposed arrangement.

3. Background

3.1 Background to the Australian National Kennel Council Limited

ANKC is the peak body in Australia responsible for promoting breeding, showing, trialling, obedience, and other canine-related activities and the ownership of purebred dogs in Australia. ANKC functions as a co-ordinating body between the peak canine bodies in each state and territory, who in turn have the responsibility of interacting with the public in their respective state or territory. ANKC also has responsibility of maintaining a register of recognised purebred dogs.

ANKC, in its current form as a company limited by guarantee, was formed on 1 July 2011 with the peak canine bodies in each state and territory acting as members of ANKC (**ANKC Member Bodies**). However, ANKC's predecessor has had a much longer history in Australia. The first meeting to consider forming an Australian National Kennel Council was held on 14 April 1949. The Australian National Kennel Council operated as an unincorporated association until the formation of a company limited by guarantee in 2011.

3.2 Regulations of ANKC

As part of ANKC's responsibilities, one of its functions is to make and manage regulations which must be complied with and implemented by ANKC Member Bodies under ANKC's constitution. Amongst other objectives, these regulations are implemented with the primary goal of ensuring the health and welfare of dogs in Australia. The ANKC Member Bodies are required to give effect to regulations made by ANKC within its jurisdiction in order to regulate the conduct of ANKC Registered Breeders and Owners in their respective jurisdictions.

3.3 Background to the ANKC Member Bodies

ANKC Member Bodies have the responsibility of dealing with dog exhibitors, breeders and judges within their respective state and territory. Below is the list of ANKC Member Bodies:

- (a) Australian Capital Territory Canine Association Inc (trading as Dogs ACT);
- (b) The Royal New South Wales Canine Council Ltd (trading as Dogs NSW);
- (c) The North Australian Canine Association Inc (trading as Dogs NT);
- (d) Canine Control Council (Queensland) Ltd (trading as Dogs Queensland);
- (e) The South Australian Canine Association Inc (trading as Dogs SA);
- (f) The Tasmanian Canine Association Inc (trading as Dogs Tasmania);
- (g) The Victorian Canine Association Inc (trading as Dogs Victoria); and
- (h) The Canine Association of Western Australia Inc (trading as Dogs West).



One of the services offered by ANKC Member Bodies is the registration of dogs (**Registration**). The primary purpose of Registration is to certify whether a dog is of known, recognised and registered parentage of the same breed. The Registration service offered by ANKC Member Bodies is not a legal requirement and differs from registration requirements of local councils.

Specifically, there are two types of Registrations offered by ANKC Member Bodies:

- (a) Registration on the Main Register this type of Registration confers full rights for a dog to have their progeny registered as purebreds and to participate in conformation shows for titles:
- (b) Registration on the Limited/Associate Register this type of Registration confirms that a dog is pedigreed, but cannot be shown at conformation shows for titles and cannot have their progeny registered as purebreds. This type of Registration is open to dogs that are sterilised (which must be evidenced by a sterilisation certificate) and permanently identified (such as with a microchip). The Associate Register will record the following information in respect of each dog on the Register: name, sex (indicated as either neutered or sprayed), microchip number, date of birth (if known) and colour. The breed or cross breed may be recorded in the notes field of the Associate Register for further reference. Dogs registered on the Associate Register are still eligible to compete in obedience, agility and other types of dog trials or sports.

There are a number of benefits to Registration with ANKC Member Bodies (or another registration organisation recognised by ANKC):

- Registration with the ANKC Member Bodies (or recognised registration body) provides certainty of family lineage as supported by pedigree records dating back over a century and whether a dog conforms to physical characteristic and traits typical of their breed as recognised by the ANKC;
- 2. Registered dogs are eligible to participate in the Canine Hip and Elbow Dysplasia Scheme (CHEDS) and Australian Canine Eye Scheme (ACES) which offers qualified certification in respect of a range of congenital and inherited conditions; and
- 3. Registration permits a dog to enter into national and international dog shows and events organised by or affiliated with ANKC Member Bodies.

3.4 National Code of Ethics of Responsible Dog Ownership

The National Code of Ethics of Responsible Dog Ownership (**Code of Ethics**) is a regulation of ANKC that mandates a standard of conduct relating to dog ownership. It is required to be implemented by each ANKC Member Body in their respective states and territories. ANKC Registered Breeders and Owners are, in turn, required to comply with the Code of Ethics as implemented by their ANKC Member Body. A copy of the current version of the Code of Ethics is annexed to this Submission as Annexure A.



4. Proposed amendment to the National Code of Ethics of Responsible Dog Ownership

4.1 Proposed amendment

One of the requirements under the Code of Ethics is that breeders registered as members of ANKC Member Bodies must register all puppies bred by them. The provision specifies the following:

23. A member shall register all puppies bred by that member that are living at the date of registration. Such registration must include all puppies from the litter on the one litter registration application form and must be applied for within eighteen [18] months of the date of whelping or prior to sale or rehoming.

ANKC proposes to insert a new provision to supplement that provision which mandates ANKC Registered Breeders and Owners to register pupples with canine registration bodies which are recognised by the ANKC (**Proposed Amendment**). Recognised canine registration bodies will consist of the ANKC Member Bodies and other overseas canine organisations as specified in paragraph 6.2 of these submissions. Specifically, the provision is intended to be inserted is as follows:

A member must register dogs bred or owned by them with a registration body recognised by ANKC Ltd.

4.2 Rationale

The rationale for the Proposed Amendment is to address the following concerns of ANKC:

- (a) the health and welfare of dogs that are only registered with unrecognised bodies (and not with bodies recognised by ANKC);
- (b) that breeders, who purport to be registered as members of ANKC Members Bodies (whether or not that is in fact the case), are engaging in conduct that may mislead, deceive or, at the very least, confuse the public by marketing dogs as being "registered" (giving an overall impression that they are Registered with a body recognised by ANKC) when in fact it is registered with some other unrecognised registration bodies. ANKC is aware of practices in which dogs registered with unrecognised registries are sold as "ANKC registered" to unsuspecting purchasers who believe they are purchasing pure bred dogs Registered with canine registration bodies recognised by ANKC and are able to enjoy the benefits as specified in paragraph 3.3 of these submissions, when in fact that is not the case.

In particular, it appears that a number of the unrecognised registries were primarily established so that breeders can bypass ANKC's rigorous requirements for pure bred pedigree Registration. As far as ANKC is aware, these registries do not:

(c) require compliance with a set of breeding requirements which is of comparable stringency to ANKC's Code of Ethics and regulations (in particular, Regulation Part 6 in respect of the Register & Registration). Without limitation, the unrecognised registries do not generally restrict the frequency of breeding and ages for breeding female dogs; and



(d) have comparable animal welfare initiatives such as maintenance of a hereditary disease database (which ANKC does through its Officially Registered Canine Health Information Database (ORCHID)) or run health certification schemes (such as ANKC's Canine Hip and Elbow Dysplasia Scheme (CHEDS) and Australian Canine Eye Scheme (ACES)).

4.3 Enforcement of a breach of Code of Ethics

If ANKC Registered Breeders and Owners are suspected of contravening the Code of Ethics, ANKC Member Bodies have in place published processes to investigate such conduct and provide ANKC Registered Breeders and Owners with an opportunity to be respond to such allegations (or otherwise be heard before a panel).

A copy of the investigate process applicable to Dogs NSW (the ANKC Member Body in NSW) is enclosed as Annexure B for reference. If the Code of Ethics is found to be breached, and the panel or investigation committee considers that a penalty is appropriate, they may proceed as follows:

- (a) reprimand the member;
- (b) impose upon the member such fine as it may think appropriate in the circumstances;
- (c) disqualify the member from exhibiting or handling an exhibit, or from acting as a Show official, or from admission to a Show;
- suspend the member from membership of the ANKC Member Body for a specific period;
- (e) require the member to tender his resignation from the ANKC Member Body;
- (f) terminate the member's membership of the ANKC Member Body; or
- (g) impose upon the member any combination of the above.

Whilst each state and territory ANKC Member Body determines and publishes its own processes, the general process, and the measures to ensure procedural fairness, are consistent across all ANKC Member Bodies.

5. Particulars of conduct for which authorisation is sought

ANKC seeks authorisation in respect of the Proposed Amendment pursuant to section 88(1) of the CCA. Specifically, the provisions of the CCA for which ANKC is seeking authorisation are as follows:

- (a) cartel conduct (section 45AD of the CCA);
- (b) anti-competitive contracts, arrangements or understandings (section 45 of the CCA); and
- (c) exclusive dealing (section 47 of the CCA).




6. Market information and concentration

6.1 Overview of market

In ANKC's view, the supply chain for Registration services in Australia can be summarised by the diagram below:

Diagram 4.1



As outlined above, ANKC considers that the market for Registration services can be broadly divided into two groups:

- (a) Registration services provided by ANKC Member Bodies or other ANKC recognised canine registration bodies; and
- (b) Registration services provided by registration organisations not recognised by ANKC.

There is also a significant number of breeders or dog owners who do not seek to Register their dogs at all. In a report published by ANKC in 2017 titled "A Forensic View of Puppy Breeding in Australia", ANKC estimates that, in 2016, 85% of all puppies (over 400,000 puppies) were bred by breeders who were <u>not</u> registered as members of ANKC Member Bodies (and therefore, are not registered through registration services provided by ANKC Member Bodies).

6.2 ANKC, ANKC Member Bodies and recognised registration bodies

As noted in section 3, ANKC does not itself provide Registration services.

Registration services are provided by the ANKC Member Bodies in each state and territory in Australia. ANKC is prepared to recognise other organisations within Australia to provide Registration services if the practices of those organisations materially meets the Code of Ethics and other regulations, codes and rules of ANKC. ANKC does not consider there are currently any other organisations in Australia that comply.



As of the date of these submissions, ANKC also recognises the following overseas canine organisations as registration bodies:

- (a) the American Kennel Club (website: www.akc.org);
- (b) the Kennel Club (UK) (website: www.the-kennel-club.org.uk);
- (c) the Canadian Kennel Club (website: www.ckc.ca/en); and
- (d) all other full members, associate members and contract partners of Federation Cynologique Internationale (as specified at http://www.fci.be/en/members/).

6.3 Other unrecognised registration organisations

ANKC is aware of a number of organisations that offer Registration services in Australia to breeders and dog owners. In particular, ANKC notes the following organisations:

AAPDB provides accreditation to breeders which
have agreed to abide by a strict code of ethical behaviour, completed their breeder training and have
undertaken an animal focused, quality assurance audit of their premises by a practicing veterinarian.

7. Impact of proposed amendment and public benefit

7.1 Likely impact of Proposed Amendment

ANKC submits that, the Proposed Amendment has, or is likely to have, minimal detriment to the Australian market for Registration services.

ANKC is aware of only a very small number of breeders registered as members of ANKC Member Bodies that currently obtain Registration services from registration organisations not recognised by the ANKC. As noted in section 6.1 above, ANKC estimates that in 2016 only 15% of all puppies were bred by breeders registered as members of ANKC Member Bodies. It is acknowledged that those breeders are more likely to seek Registration services from ANKC Member Bodies when the Proposed Amendment is given effect.

However, breeders are not required to comply with the Proposed Amendment if they are not members of ANKC Member Bodies. Accordingly, breeders also have the option of sidestepping compliance with the Proposed Amendment by foregoing their individual memberships with ANKC Member Bodies.

The Proposed Amendment only impacts breeders who are registered as members of ANKC Member Bodies. It is not expected that the Proposed Amendment would have any impact on owners of dogs (that have not been Registered) seeking Registration services from ANKC recognised bodies or other unrecognised registration organisations.

For the reasons noted above, ANKC also submits that the Proposed Amendment would not have the effect, or would not be likely to have the effect, of substantially lessening competition.

7.2 Public benefit

ANKC submits that the Proposed Amendment would result, or be likely to result, in a benefit to the public that outweighs any detriments that will or likely to result.

As Registration with ANKC Member Bodies and other ANKC recognised registration organisations confers a number of benefits (as specified in section 3.3 above), dogs which have been Registered with ANKC Member Bodies and other registration organisations



typically command higher prices. In ANKC's view, the Proposed Amendment would result, or be likely to result in the following public benefits:

- (a) purchasers of dogs from breeders can have certainty that breeders who are registered as members of ANKC Member Bodies have Registered its puppies with the ANKC Member Bodies or another registration organisation recognised by ANKC. Accordingly, if they choose to pay higher prices to purchase dogs from those breeders, they will enjoy the benefit which Registration confers as noted in section 3.3; and
- (b) purchasers of dogs can make informed choices as to whether to purchase from breeders who are registered as members of ANKC Member Bodies (who would have Registered dogs with ANKC Member Bodies or another registration organisation recognised by ANKC) or other breeders (who may have Registered dogs with registration bodies not recognised by ANKC or have obtained no Registration at all).

More importantly, the Proposed Amendment is an initiative of ANKC to improve the health and welfare of dogs bred by members of the ANKC Member Bodies. The implementation of the Proposed Amendment will better ensure:

- (c) compliance with ANKC's breeding requirements as set out in ANKC's Code of Ethics or regulations; and
- (d) participation in ANKC's animal welfare initiatives including contributions to ANKC's Officially Registered Canine Health Information Database (ORCHID) or participation in ANKC's Canine Hip and Elbow Dysplasia Scheme (CHEDS) and Australian Canine Eye Scheme (ACES).

- 13. A member shall not breed a bitch (except under extenuating circumstances) causing it to whelp more than twice in eighteen months without the prior approval of the member's Member Body.
- 14. A member shall not breed a bitch (except under extenuating circumstances) causing it to whelp more than six times without prior veterinary certification of fitness for further breeding, and without prior approval of the member's Member Body.
- 15. A member shall not breed a bitch which is eight years of age and over unless it complies with ANKC Regulations Part 6 Clause 8 3.
- 16. A member shall not permit any of that member's pure bred dogs to be mated to a dog of a different breed, to a cross bred dog, to an unregistered dog of the same breed, or to a dog not on the Main Register without the prior approval of the member's Member Body.
- 17. A member shall take responsible action to reduce the incidence of hereditary diseases in accordance with the ANKC Ltd Code of Practice for Hereditary Diseases.
- 18. A member shall not, within Australia, sell or otherwise transfer from that member's care any puppy under eight [8] weeks of age without the approval of the member's Member Body.
- 19. A member exporting a puppy must comply with all current requirements of the Australian Department of Agriculture. (10/15)
- 20. A member shall not knowingly sell a dog to any person residing in an overseas country known to be involved in the utilisation of dogs for the meat trade without first satisfying the member's Member Body that the purchaser is a member of an ANKC Ltd recognised canine controlling body in the overseas country. The member and purchaser must further acknowledge in writing to the member's Member Body that the intention of the sale is for the improvement of the quality of that breed in the overseas country, and not for any other purpose.
- 21. A member shall ensure that persons acquiring dogs from that member understand the requirements for the care, welfare and responsible ownership of the dog, and that they have the time and facilities, e.g. adequate fences, sufficient room and proper shelter, to fulfil their responsibilities.
- 22. A breeder shall be expected to maintain reasonable contact with the purchasers of dogs from that breeder and to offer continued advice and reasonable assistance.
- 23. A member shall register all puppies bred by that member that are living at the date of registration. Such registration must include all puppies from the litter on the one litter registration application form and must be applied for within eighteen [18] months of the date of whelping or prior to sale or rehoming. **(06/08) (10/16)**
- 24. A member shall provide to all recipients of dogs sold or otherwise disposed of by that member, written details of:
 - .1 The breed characteristics;
 - 2 Vaccination record and / or requirements;
 - 3 Responsible dog ownership information; and
 - .4 All documentation required by the member's Member Body.
- 25. A member shall not incorrectly describe nor knowingly misrepresent the characteristics of a breed.
- 26. A member shall ensure that all dogs sold or disposed of by that member are in the best possible state of health. Where a dog with a health issue or disability is disposed of the member must obtain from the recipient written and signed acknowledgement of the condition of the dog.
- 27. A member shall not:
 - .1 Sell or dispose of a dog to a commercial pet wholesaler or retail pet shop. (10/15)
 - 2 Allow a dog owned by that member to be given as a prize or donation or to be auctioned.

General

- 28. A member shall not conduct or permit mother / son, father / daughter or brother / sister matings. The member is fully aware that puppies as a result of such matings will not be registered without first gaining approval from the Member Body for the mating for scientifically proven welfare or veterinary reasons. (Added EAP 07/11)
- 29. A member who provides or makes available a dog for use in a film, advertisement,

promotion, or any media or public display must ensure that:

- .1 The dog is portrayed in a manner consistent with its breed characteristics and temperament as described in the Standard for that breed; and
- 2 The dog is presented in a manner that is unlikely to create a negative reaction to dogs generally or that breed in particular and that if there is any likelihood of a negative impression, this is at the same time corrected through the development of a story line that presents the dog or breed in a balanced manner.
- 30. A member shall not indulge in false or misleading advertising relating to the conformation, characteristics or performance of that member's dog.
- 31. A member shall not misrepresent nor malign the conformation, characteristics or performance of another member's dog.
- 32. It is mandatory for an ANKC Ltd Member Body Membership Number to be displayed on any advertisement for dogs whatever the media and all members must include the following wording in their advertisements:
- "Please contact Dogs [insert State/Territory] on email: [insert email address] to verify my membership". (Amended 10/17, 6.1)
- 33. A member shall not use spiked or electronic collars for the purposes of training. (Added 10/18, 6.17.1)

Annexure B- Published investigative process (Dogs NSW)

DOGS NSW COMPLAINTS PROCEDURES

- 1. Dogs NSW will not deal with anonymous complaints, whether by telephone, email or in writing.
- 2. Dogs NSW will not become involved in disputes between members in relation to the sale of dogs. These are usually private matters to be determined by the contractual agreements between parties. Disputes on such matters should be resolved through NSW Fair Trading or the Courts and not by Dogs NSW.
- Complaints must be submitted directly by the complainant to Dogs NSW (not via a third party).
- 4. The complainant must, in the first instance, make all attempts to resolve the problem with the member who is the subject of their complaint, eg, breeder; ie, discuss options of refund, partial refund or replacement, DNA testing, etc.
- 5. If unable to come to an agreement, the complainant should submit the complaint on the Dogs NSW-Complaint Lodgement Form to Dogs NSW, along with all evidence such as documentary proof they have attempted to resolve the matter and, where the breeder/seller has refused, proof of the breeder's/seller's refusal, receipt/proof of purchase, veterinary report, photographic evidence, etc.
- 6. The complainant should, **on the Dogs NSW-Complaint Lodgement Form**, include reference to the specific Dogs NSW Regulation which it is alleged is being breached. Dogs NSW Regulations can be viewed on the website at http://www.dogsnsw.org.au/members/member-information/regulations.html.

It should be noted that in some cases, a complaint lodgment fee of \$150.00 is required in order for the complaint to progress. (Refer Regulations Part XI - Inquiries, Investigations & Appeals, Section 3.4(a), which states:

3.4(a) Until the Board of Directors otherwise determines, a fee of \$150.00 is payable upon the lodgment of a complaint with the RNSWCC Secretary.

(Refer to Page 2 for complaint fee requirements)

Upon receipt of **all** of the above requirements and confirmation that the respondent is a current financial member of Dogs NSW, the complaint will be forwarded to the Dogs NSW Disputes Assessment Panel for consideration.

SERIOUS MANNER. As you may be aware, there are various types of complaints received by Dogs NSW Office and these are dealt with as follows:-

ETHICS & WELFARE COMPLAINTS

These complaints relate to issues such as unethical breeding, sale of a dog in ill health and other similar clauses in the Code of Ethics, however, it should be noted that Dogs NSW Regulations Part XIII-Code of Ethics, Clause 23 states:-

23. No dog should be sold or transferred in a state of ill health. It is a defence to any complaint against a Member for contravention of this Clause if the Member proves that it was not reasonably practicable for the Member to know that the dog was in ill health at the time of sale or transfer.

Ethics & Welfare complaints do <u>NOT</u> attract a complaint fee and are referred to the Dogs NSW Ethics & Welfare Working Party once advice has been sought and obtained from the Dogs NSW Honorary Vets.

ANIMAL WELFARE & COMMUNITY LIAISON COMPLAINTS

These complaints relate to matters such as:-

- Advertising by a Dogs NSW Member of unregistered dogs, cross breeds, unrecognised breeds, dogs sold without papers, etc,
- Non-display of membership number on an advertisement or advertising to be a registered breeder when they are not
- Complaints of poor kennel conditions or over breeding
- Other matters that may require an inspection of a Dogs NSW Member's premises.

AWCLO complaints do <u>NOT</u> attract a complaint fee and should be referred to the CEO for onforwarding to the Animal Welfare & Community Liaison Officer.

DISPUTES ASSESSMENT COMPLAINTS

These complaints are generally direct breaches of ANKC Ltd and/or Dogs NSW Regulations and Dogs NSW Social Media Policy, such as:-

- Altercation at a show (Misconduct)
- Unsportsmanlike behaviour (Misconduct)
- Failure to resolve a Non-supply of Registration papers matter
- 3rd Offence breach of Code of Ethics
- Disparage a Judge at a Show
- Incorrectly enter a dog in a show
- Forging documents
- Making derogatory or disparaging remarks by a Dogs NSW member on Facebook or other forms of social media
- Cyber bullying by a Dogs NSW Member
- Dogs NSW Member using obscene or sexually explicit language or material in any form of media

Disputes Assessment Panel complaints <u>DO</u> attract a complaint fee of \$150.00 and are referred to the Disputes Assessment Panel for consideration and determination as to whether the matter should proceed to an Inquiry Hearing.

The above lists are not exhaustive lists, only examples.
