Hunter Resource Recovery applications for authorisation (AA1000647 & AA1000648) - interested party consultation

On 10 and 18 August 2023, the Australian Competition and Consumer Commission (the **ACCC**) received two applications for authorisation from Hunter Resource Recovery (HRR). This letter is to invite you to comment. You are welcome to pass this letter on to others who may wish to make submissions.

HRR, on behalf of itself, its Member Councils, (Cessnock City Council, Lake Macquarie City Council, Maitland City Council and Singleton Shire Council), and each of Dungog Shire Council, Muswellbrook Shire Council and Upper Hunter Shire Council, is seeking authorisation¹ under the *Competition and Consumer Act 2010* (Cth), for 25 years to jointly procure (through a tender process) and contract for the establishment of a recycling processing and sorting facility.

HRR, on behalf of itself and its Member Councils, (Cessnock City Council, Lake Macquarie City Council, Maitland City Council and Singleton Shire Council), has also sought authorisation² under the *Competition and Consumer Act 2010* (Cth), for 12 years to jointly procure (through a tender process) and contract for kerbside dry recyclate collection in each Member Council's Local Government Area.

HRR has sought interim authorisation with respect to both above applications.

Given the two applications are closely related, the ACCC intends to assess them both at the same time.

Making a submission

The ACCC invites you to make a submission on the applications for authorisation. In making your submission, please provide information, evidence and views about the likely public benefits, effects on competition and any other public detriment that you consider will result from the proposed conduct.

If you intend to provide a submission, please do so by **22 September 2023**. If you wish to request an extension, please contact us on the details below as early as possible. Submissions after the due date (or after any extension granted) may not be taken into account.

Your submission **will** be placed on the ACCC's <u>authorisations public register on the internet</u> unless you have made a request (with reasons) for us to exclude part or all of the submission from the public register.
