Virgin Australia Airlines Pty Ltd application for authorisation AA1000608 – interested party consultation

On 14 April 2022, the Australian Competition and Consumer Commission (the **ACCC**) received an application for authorisation from Virgin Australia Airlines Pty Ltd (**Virgin Australia**) on behalf of itself and partner airlines within a specified class of international operating carriers (**Partner Carriers**). This letter is to invite you to comment. You are welcome to pass this letter on to others who may wish to make submissions.

Virgin Australia is seeking authorisation¹ under the *Competition and Consumer Act 2010* (Cth). Authorisation would give it legal protection from competition laws to make and give effect to codeshare agreements with Partner Carriers which contain pricing provisions that may trigger the prohibition against resale price maintenance (the **Proposed Conduct**).

Virgin Australia is seeking authorisation for 5 years. A full copy of the application for authorisation is available on the ACCC's <u>authorisations public register</u>.

Interim authorisation

Virgin Australia has also requested interim authorisation² to allow it to commence marketing United Airlines operated services under a codeshare agreement that includes pricing provisions that give rise to the Proposed Conduct.

Making a submission

The ACCC invites you to make a submission on the application for authorisation. In making your submission, please provide information, evidence and views about the likely public benefits, effects on competition and any other public detriment that you consider will result from the proposed conduct.

If you intend to provide a submission in relation to interim authorisation, please do so by **5:00PM AEST** on **Tuesday 3 May 2022**. Extensions are not normally granted for submissions on interim authorisation.

If you intend to provide a submission in relation to the substantive application, please do so by **5:00PM AEST** on **Friday 20 May 2022**. If you wish to request an extension, please contact us on the details below as early as possible. Submissions after the due date (or after any extension granted) may not be taken into account.
