**Qantas Airways Limited and American Airlines Group Inc. - application for revocation of authorisations A91502 and A91503 and substitution of new authorisation AA1000532 – interested party consultation**

The Australian Competition and Consumer Commission (the **ACCC**) has received an application for revocation of authorisations A91502 and A91503 and substitution of replacement authorisation AA1000532 (**reauthorisation**) from Qantas Airways Limited and American Airlines Group Inc and their related bodies corporate (**Qantas and American Airlines**) in order to continue their trans-Pacific aviation alliance.

This letter is to invite you to comment on the application.

**Application for re-authorisation**

The conduct for which Qantas Airways Limited and American Airlines Group Inc are seeking reauthorisation is substantially the same as was permitted by authorisations A91502 and A91503 which expire on 18 March 2021. Reauthorisation would allow Qantas and American Airlines to coordinate their operations between Australia/New Zealand and the United States, Canada, and Mexico pursuant to a joint coordination agreement for a further five years (i.e. until November 2025).

**Interim authorisation**

Qantas and American Airlines have also requested interim authorisation to allow them to facilitate a seamless continuation of the existing joint business into 2021.

The ACCC decides whether to grant interim authorisation on a case by case basis. In doing so, the ACCC will usually consider a range of factors, including: harm to the applicant and other parties if interim is, or is not, granted; possible benefit and detriment to the public; the urgency of the matter's need for interim authorisation; and the extent to which whether the market will change be likely/able to return to substantially its pre-interim authorisation state if the ACCC should later deny authorisation.

**Request for submissions**

The ACCC invites you to make a submission on the application for reauthorisation and/or the application for interim authorisation. In making your submission, please provide information,

evidence and views about the likely public benefits, effects on competition and any other public detriment that you consider will result from the proposed conduct.

If you intend to provide a submission on either application, please do so by **20 November 2020**. If you wish to request an extension, please contact us on the details below as early as possible. Submissions after the due date (or after any extension granted) may not be taken into account.

Your submission **will** be placed on the ACCC's [authorisations public register on the internet](#) unless you have made a request (with reasons) for us to exclude part or all of the submission from the public register ([see Guidelines for Excluding Information from the Public Register](#) for more information on how to make a request and how we assess requests).

The ACCC will progress its assessment of the application in a timely manner. An indicative timetable is set out below for your information.

<b>29 October 2020</b>	Public consultation process begins.
<b>20 November 2020</b>	Closing date for submissions from interested parties.
<b>December 2020/January 2021</b>	Draft determination and interim authorisation decision.
<b>January/February 2021</b>	Public consultation on draft determination including any conference if called.
<b>February/March 2021</b>	Final determination.
