Australian Banking Association Ltd (cash-in-transit services) – Application for authorisation AA1000654 – Interim authorisation decision / Interested party consultation

On 30 November 2023, the Australian Competition and Consumer Commission (ACCC) received an application for authorisation by the Australian Banking Association Ltd (ABA). This letter is to invite you to comment on this application. You are welcome to pass this letter on to others who may wish to make submissions.

The ABA is seeking authorisation¹ under the Competition and Consumer Act 2010 (Cth). Authorisation would enable the ABA, its member banks, and other industry participants who distribute and/or utilise cash in their businesses to discuss and develop arrangements to support ongoing access to cash across the Australian economy.

The application for authorisation follows concerns expressed by the major supplier of cash-in-transit services in Australia, Armaguard, that the industry is not sustainable in its current form. Cash-in-transit services involve providing cash transport, management and processing services. These services are provided to banks, retailers and independent ATM operators.

Authorisation is sought until 30 June 2024.

This application relates only to discussions and reaching in-principle agreements about an industry response to support ongoing access to cash. The ABA has advised that before adopting and implementing an agreed industry response a separate ACCC authorisation for the proposed way forward would be sought if required.

Interim authorisation decision

The ABA has also requested interim authorisation to enable industry participants to engage in the proposed conduct while the substantive application for authorisation is being assessed by the ACCC.

On 6 December 2023, the ACCC granted interim authorisation with conditions. A copy of the ACCC's interim authorisation decision is <u>attached</u> and is also available on the <u>ACCC's public register</u>.

As noted in the attached decision, the ACCC may review its decision on interim authorisation at any time. The ACCC's decision in relation to interim authorisation should not be taken to be indicative of whether or not final authorisation will ultimately be granted.

Making a submission

The ACCC invites you to make a submission on the application for authorisation. In making your submission, please provide information, evidence and views about the likely public benefits, effects on competition and any other public detriment that you consider will result from the proposed conduct.

If you intend to provide a submission, please do so by 19 January 2024.

If you wish to request an extension, please contact us on the details below as early as possible. Submissions after the due date (or after any extension granted) may not be taken into account.

Submissions should be lodged via the web form accessible on the public register page for this matter. Alternatively, if you would like to provide comments orally, please contact Elizabeth Batten via the details at the end of this letter.

Your submission **will** be placed on the ACCC's <u>authorisations public register on the internet</u> unless you have made a request (with reasons) for us to exclude part or all of the submission from the public register (see <u>Guidelines for Excluding Information from the Public Register for more information on how to make a request and how we assess requests).</u>

Timetable

The ACCC will progress its assessment of the application in a timely manner. An indicative timetable is set out below for your information, and an up-to-date version (including any changes) will be posted on the public register.

30 November 2023	Lodgement of application and supporting submission.
6 December 2023	ACCC decision regarding interim authorisation. Public consultation process begins.
19 January 2024	Closing date for submissions from interested parties.
February - March 2024	Draft determination.
March - April 2024	Public consultation on draft determination including any conference if called.
April 2024	Final determination.
