A meeting of AEMO representatives and industry executives was held on Tuesday 7 April 2020 at 5:30pm. At the meeting, AEMO provided an overview of the Interim Authorisation to participants on the call, including the activities covered, the conditions of authorisation and the further decision to be made by the ACCC in relation to the balance of the authorisation application. A brief discussion followed about establishing teams to deal with relevant COVID issues, including the activities the subject of the Interim Authorisation.
