



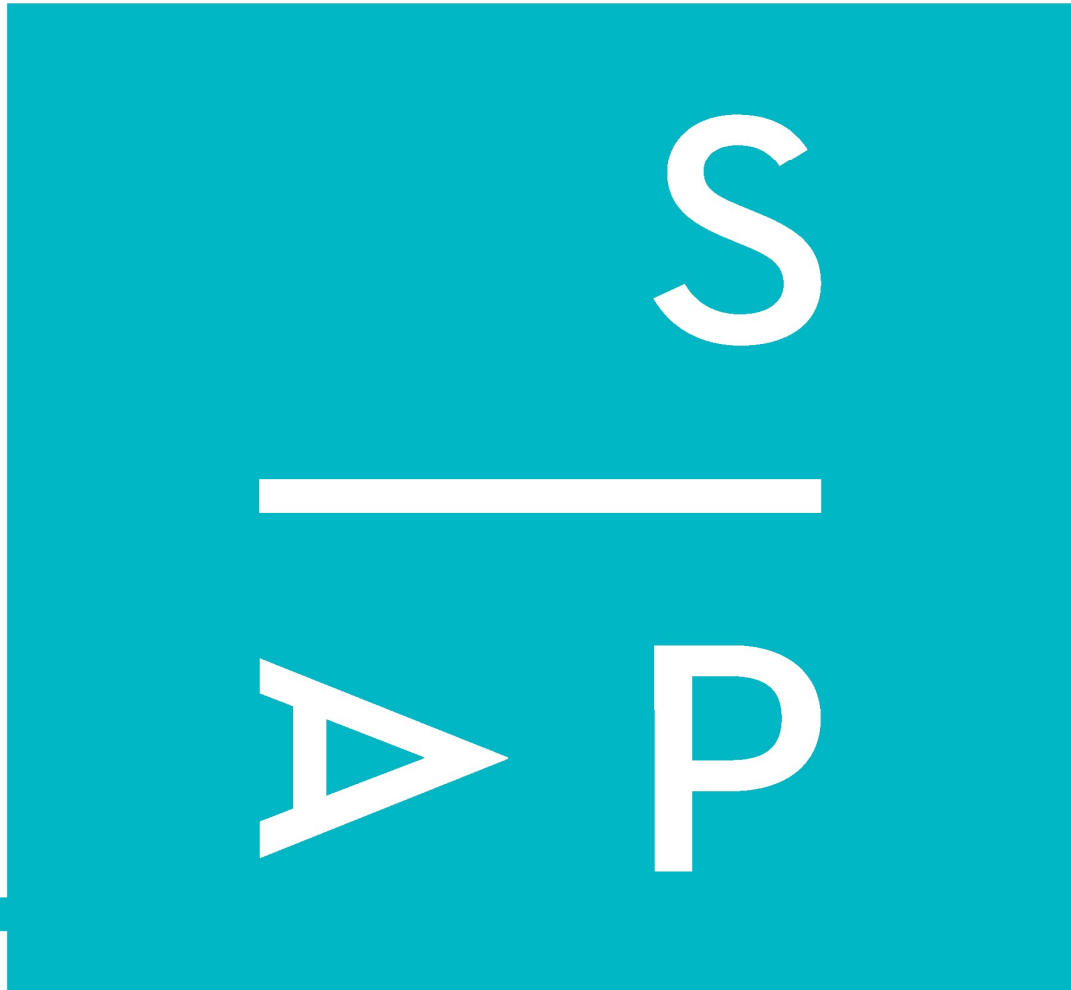

MINIMUM BASIC SCRIPT FEE (MBSF)

In accordance with clause 3.1 of the Children's Television Agreement, the MBSF and earning thresholds increase by annual CPI (September) on 1 January each year unless otherwise agreed between SPA and the AWG

All fees and earnings thresholds under this Agreement, with the exception of the MBSF will become effective on 1 January 2011, and will increase each year, on 1 January, by the annual CPI, using the figure published by the Australian Bureau of Statistics in its most recent quarterly release
