Re: Request for submissions: Aurizon Holdings Limited's proposed acquisition of Flinders Logistics Pty Ltd

The Australian Competition and Consumer Commission (ACCC) is seeking your views on the proposed acquisition of Flinders Logistics Pty Ltd (Flinders Logistics), and its wholly owned subsidiary Pirie Bulk Pty Ltd (Pirie Bulk), by Aurizon Holdings Limited (Aurizon) (the proposed acquisition).

Flinders Logistics provides bulk and some break bulk stevedoring services at Port Adelaide and Port Pirie, South Australia. Aurizon (ASX:AZJ) provides rail haulage services in Queensland, New South Wales, Victoria, South Australia, Western Australia and the Northern Territory and operates below rail networks, including the Tarcoola to Darwin railway network. Further details are provided at **Attachment A.**

The ACCC's investigation is focused on the impact on competition. In particular, we are seeking your views on:

- whether customers would have access to alternative suppliers of haulage, stevedoring and/or bulk handling services at Port Adelaide and Port Pirie
- whether new haulage, stevedoring and/or bulk handling services are likely to face increased barriers to entry as a result of the proposed acquisition
- whether the proposed acquisition is likely to give Aurizon the ability and or incentive to foreclose or limit rival stevedores' ability to attract or retain customers at Port Adelaide.

Further issues you may wish to address are set out in **Attachment B**.

This matter is public and you can forward this letter to anybody who may be interested.

The legal test which the ACCC applies in considering the proposed acquisition is in section 50 of the *Competition and Consumer Act 2010*. Section 50 prohibits acquisitions that are likely to have the effect of substantially lessening competition in a market.

Attachment A

Flinders Logistics

Flinders Logistics operates a stevedoring and logistics business for bulk and limited break bulk at Berths 18-20 and 29 at Port Adelaide and at Port Pirie. Its wholly owned subsidiary, Pirie Bulk, provides cargo handling services at Port Pirie.

Aurizon

Aurizon is an ASX listed (ASX: AZJ) national freight company which, among other things, provides rail haulage services to the mineral, industrial and agricultural industries. Aurizon currently provides rail haulage to and from Port Adelaide. Aurizon does not currently provide any haulage services to or from Port Pirie. Aurizon also operates below rail networks, including the Tarcoola to Darwin railway network.

The proposed acquisition

Aurizon, through its wholly owned subsidiary, Aurizon Operations Limited, proposes to acquire Flinders Logistics under a share sale agreement. As part of the acquisition, Aurizon will acquire the assets associated with Flinders Logistics' stevedoring operations and Flinders Logistics will enter into underleases for certain land currently used by Flinders Logistics or its wholly owned subsidiary, Pirie Bulk. Existing common areas (including those required for berth access) will remain common user.

In your response, please consider the likely timeframe for market entry and provide details about barriers to entry (i.e. the costs of establishing a competing business and any incumbency advantages to be overcome), including regulatory barriers and any challenges to access to key inputs. Please provide examples of recent entry where possible.
- 10. Please explain whether, and why / why not, the increased vertical integration of Aurizon will impact competition at any level of the supply chain.
- 11. Please explain whether or not the proposed acquisition will give Aurizon the incentive or ability to restrict or foreclose access to infrastructure which is critical to you competing. Please provide details including any critical infrastructure which Aurizon currently holds,

or will hold post-acquisition, and how the acquisition alters Aurizon's current ability and incentive to frustrate or foreclose competitors.
