### Telstra - TPG – Proposed MOCN - Table 5 in Application

As discussed, we have realised that a row was inadvertently left out of Table 5 of the Application relating to 1800MHz spectrum. To avoid any potential confusion between Table 5 and Table 12 of the Application, we are writing to clarify that as set out in Table 12, Telstra's 1800MHz spectrum will be pooled for use by TPG and Telstra in the MOCN footprint but not TPG's 1800MHz holdings. For ease of reference, an updated Table 5 is provided below.

Table 5. Spectrum pooled under the MOCN

Band	Telstra holding (and current use)	TPG holding (and current use)	Pooled spectrum in MOCN footprint
700MHz (FDD)	2x20MHz (4G)	2x15MHz (almost no use in the 17% Regional Coverage Zone)	2x30MHz (TPG retain 2x5MHz)
850MHz (FDD)	2x15MHz (3G, some 5G)	2x5MHz (limited 4G coverage)	2x20MHz
1800MHz (FDD)	2x35 – 2x40* (4G)	2x10 – 2x20* (very limited 4G coverage in the 17% Regional Coverage Zone)	2 x 35 – 2 x 40* MHz (TPG retains its 1800MHz holdings)
2100MHz (FDD)	2x10MHz (4G)	2x5MHz (limited 4G coverage)	2x15MHz
2600MHz (FDD)	2x40MHz (4G)	Nil	2x40MHz
3600MHz (TDD)	50 - 80MHz (5G)	20-45MHz (not deployed in 17% Regional Coverage Zone)	90-125MHz
