Hi Hannah

Both Wodonga City Council and Indigo Shire Council are partner councils within the North East WRRG region.

We are instructed that they both participated in a previous procurement collaboration with Albury City Council (which included two other NSW based councils) and those councils currently hold contracts for domestic waste and recycling collection/processing/disposal services as a result of that procurement.

We are also instructed that both Wodonga City Council and Indigo Shire Council have elected to participate in the procurement of domestic waste and recycling services with Albury City Council and other NSW councils (the subject of the particular application for authorisation referred to in your email below). Wodonga City Council and Indigo Shire Council therefore will not be participating in the collaborative procurement of kerbside waste and recycling services under our application for authorisation (those services are currently out to the market after receiving ACCC interim authorisation).

The reason for including both Wodonga City Council and Indigo Shire Council as applicants within our clients' application was to allow them to have the ability to participate in future collaborative procurement opportunities for other services, including Resource Recovery Centre specific waste and recycling materials (noting that services pertaining to these specific materials are not included within the Albury application).

Accordingly, we do not consider that Wodonga City Council and Indigo Shire Council being applicants under the two separate applications will harm competition for the procurement of specific kerbside/domestic waste and recycling services.

We trust this is helpful however please let me know if you require any further information.
