Australian Energy Services Pty Ltd ("AES") Notification of Exclusive Dealing

We act for AES and enclose our client's Exclusive Dealing Notification.

As you will see from the Notification, the conduct in question concerns the contractual requirement that customers of AES will enter into contracts for the supply of electricity with the supplier selected by AES as offering the best "deal". The conduct therefore falls within section 47(6). A copy of the form of contract is enclosed.

With reference to the test that must be satisfied pursuant to section 93(3A), we submit there is no public detriment, and there is a significant public benefit. The customers of AES rely on it to select the cheapest supply of electricity, and AES has done so, with considerable success.

The contracts entered into by AES customers with the nominated electricity suppliers are for fixed terms. The average term is two to three years, while a small percentage (less than 5%) have terms of four to five years. By those contracts the price of electricity is fixed for the term of the contract.

When AES commenced mainstream operations in early 1998, the price of electricity at peak supply times was approximately \$20.00 per megawatt hour (for large consumers), and the price now is from \$40.00 to \$45.00. For smaller consumers, the price was approximately \$35.00, and is now approximately \$60.00. The many customers of AES (in excess of 10,000 contracts) have therefore paid far less for electricity by contracting with the suppliers nominated by AES.

We should add that the form of contract, the subject of the Notification, is being phased out, and will not be used after July this year. Under the new form of AES contract, AES is itself the supplier of the electricity.

The services in question are pricing advice and the procurement for customers of contracts with suppliers of electricity.

AES negotiates the best "deals" on electricity on behalf of business consumers of electricity. It enters into a form of contract with its customers under which it agrees to provide such a service. It provides that the customer will acquire electricity from the "nominated supplier", being the supplier AES recommends and selects for the customer. The customer then enters into a separate contract with the electrical supplier.
