  - (iv) supply other benefits or privileges as specified in 2(a) with the purchase of specified goods

on the condition that:

- (i) the purchaser of the goods is currently a Coles Myer Card credit account-holder; or
- (ii) the purchaser of the goods becomes a Coles Myer Card credit account-holder prior to the purchase of the goods;
