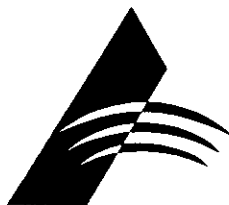

**Re: Notification of exclusive dealing conduct lodged by Traglen Oven Cleaners
(Franchising) Pty Ltd (N31143)**

I refer to the notification of exclusive dealing conduct lodged by Traglen Oven Cleaners (Franchising) Pty Ltd ("Traglen").

Notification N31143 was lodged with the Australian Competition and Consumer Commission ("the Commission") on 8 April 2002 and has been placed on the Commission's public register. Legal immunity provided by the exclusive dealing notification came into force on 22 April 2002.

You have described the conduct as Traglen entering into a franchise agreement with each franchisee that requires the franchisee to obtain cleaning products from Traglen. It is also proposed that each franchisee will be required to purchase a custom built trailer and blasting guns from Traglen to be used in conjunction with the cleaning products.

In respect of this conduct I bring to your attention the requirement under the Franchising Code of Conduct for a franchisor to disclose in the Franchise Disclosure Document any commission or rebate received through an agreement with a third party supplier.



On the basis of the information that you have provided to the Commission, it has been decided that no further action will be taken in this matter at this stage.

Please note that the Commission may act to remove the immunity afforded by this notification at a later stage if it is satisfied that the public benefit arising from the notified conduct does not outweigh the public detriment arising from the conduct.
