AMALGAMATED FOOD & POULTRY PTY LTD - NOTIFICATION

Pursuant to section 93(1) of the Trade Practices Act 1974, we enclose a Notification of Exclusive Dealing on behalf of Amalgamated Food & Poultry Pty Ltd ("AFP") in respect of proposed arrangements with Red Rooster franchisees.

We advise as follows:

- 1. under the proposed franchise agreement, the franchisee will be required to purchase all secret products ("Secret Products") and non-secret products ("Non-secret Products") to be used and supplied in the Red Rooster business from AF&P or from suppliers approved by AF&P ("Approved Suppliers");
2. the Secret Products and the Non-secret Products used in the Red Rooster network are key elements of the Red Rooster image and brand;
3. we are instructed that the purpose of the proposed supply arrangements referred to in paragraph 1 is not to lessen competition in any market but to ensure:
(a) only high quality products that are consistent with Red Rooster standards and image are used and supplied by franchisees;
(b) the marketing positioning of the Red Rooster Network;
(c) that customers get the benefit of the unique points of difference of the Secret Products used and supplied; and
(d) that the franchisees are able to meet the expectations of customers.

Accordingly, the purpose of the proposed supply arrangements is to assist maintain the value and reputation of the Red Rooster brand by ensuring

that the products used and supplied are consistent with the Red Rooster standards and image;

4. the matters referred to in paragraph 3 above are in our view public benefits of the proposed structure. The above benefits will also give the customer certainty;
5. in our view, the proposed structure will not have the effect of lessening competition in any market and may in fact help to increase competition for reasons including the following:
 - (a) the franchisees may be new entrants into the retail market for food sales. The Red Rooster image and systems may encourage better retail practices in the retail market and benefit consumers;
 - (b) the proposed structure may assist franchisees in being able to compete in the relevant retail market against supermarkets and larger competitors;
 - (c) in the wholesale market, the volumes and certainty of supply to franchisees may result in cost savings by the supplier, increasing efficiency and competition amongst suppliers. This may ultimately result in cost reductions at the retail level, thereby further enhancing interbrand competition; and
 - (d) also, the supplier may be in a better position to plan for future production, which would offer greater incentives to invest in capital improvements; and
6. we have not attempted to conclusively define the relevant markets. However, on the information to hand, in our view the market for retail food sales is characterised by a large number of participants. We do not believe there is a lessening of competition in the market as a result of the proposed supply arrangements given the large numbers of suppliers in the relevant market. There is, in our view, no public detriment that results from the conduct.

We also enclose a cheque for \$100 for the lodgement fee.

Notice is hereby given, in accordance with subsection 93 (1) of the *Trade Practices Act 1974* of particulars of conduct or of proposed conduct of a kind referred to in subsection 47 (2), (3), (4), (5), (6) or (7), or paragraph 47 (8) (a), (b) or (c) or (9) (a), (b), (c) or (d), of that Act in which the person giving notice engages or proposes to engage.

Amalgamated Food & Poultry Pty Ltd (“AF&P”)

(b) Short description of business carried on by that person

AF&P is a franchisor and in the business of granting franchises to franchisees for the operation of Red Rooster stores.

(c) Address in Australia for service of documents on that person

2. (a) Description of the goods or services in relation to the supply or acquisition of which this notice relates

Supply of retail food products.

(b) Description of the conduct or proposed conduct

AF&P proposes to supply franchise rights to franchisees under a standard franchise agreement which includes the following terms:

“Background

A. We have reviewed Your application for acceptance as a Red Rooster Franchisee and according to the statements made in Your application, We have decided to grant to You the Franchise described in this Agreement.

B. You agree to operate the Franchise according to this Agreement.

C. You acknowledge that it is essential to the maintenance of the high standards which the public has come to expect from stores operated as part of the Red Rooster System and the preservation of the Goodwill of the Red Rooster System that all Franchisees of the Red Rooster System adhere to certain uniform standards procedures and policies detailed in this Agreement and any related policy Manuals to Our satisfaction.

- D.** You have nominated the Principal as the person responsible for the management control and conduct of the Franchise in accordance with the terms and conditions of this Agreement.

6. Secret Products

6.1 Suppliers of Products

- (1) We or Our Approved Suppliers will supply to You such quantities of Our Secret Products as may be necessary for the operation of the Business.
- (2) You will place orders for the Secret Products according to Your requirements from time to time.

6.2 Terms of Payment

- (1) The Secret Products will be supplied at a price per kilogram determined by Us or Our Approved Suppliers from time to time and on Our or Our Approved Supplier's then current trading terms.
- (2) You will bear all costs of delivery and transportation of the Secret Products.

6.3 Where Payment is not made in Advance

- (1) Where in Our absolute discretion We supply the Secret Products to You without receiving payment in full in advance, You agree that You will make payment within the period specified in the invoice for those products.
- (2) Where any money is outstanding We will not be under any obligation to supply any further Secret Products to You.

7. Other Products

7.1 Our Supply of Other Products

We or Our Approved Suppliers may supply to You quantities of Non-secret Products in accordance with Your written orders specifying the varieties and quantities required from time to time.

7.2 Terms of Payment

- (1) We or Our Approved Suppliers will supply the Non-secret Products at a price determined by Us or Our Approved Suppliers plus packaging and handling costs.
- (2) You will pay all costs of delivery of the Non-secret Products.
- (3) Any Non-secret Products acquired from Us or Our Approved Suppliers will be paid for within the period specified in the invoice for those products.

7.3 Purchase from other Suppliers

- (1) If You wish at any time to acquire any Non-secret Products from a supplier other than Us or Our Approved Suppliers, You will be at liberty to do so once You have:

- (a) supplied to Us the name and address of the proposed supplier;
 - (b) provided to Us a list of all products to be acquired and the quantities of those products; and
 - (c) obtained Our approval of the purchase of such products.
- (2) If We consider it necessary, You will submit sample products to Us for testing so that We can ensure that the products meet Our standards.
 - (3) You agree that You will pay the cost of such tests unless We choose to obtain supplies of the Non-secret Products from the proposed supplier, in which case We will bear the testing costs.

7.4 Testing of Products

- (1) If We receive a submission from You pursuant to clause 7.3, We will promptly complete all the necessary enquiries and testing and will decide if the products and the supplier meet Our standards of quality, taste and performance.
- (2) We will promptly notify You of the decision made.
- (3) In making this decision, We will be entitled to consider whether the proposed supplier has the capacity and facilities to supply Your needs in the required quantities at all times and with the reliability necessary for the efficient conduct of the Business.

7.5 Details of Approved Suppliers

- (1) We will, upon request, make available to You the names and addresses of all manufacturers and suppliers of current approved Non-secret Products and Our current standards and specifications relevant to such products.
- (2) If We decide not to approve a supplier as a source of supply of any non-secret product, We will advise You in writing of the reasons for this decision.
- (3) However, if We give such an approval, We may, on reasonable grounds, later revoke or suspend the approval by written notification to You.

7.6 We Will Endeavour to Obtain Discounts

- (1) We will endeavour to obtain discounts, rebates or promotional allowances from suppliers of products, which may be used or applied by Us in Our absolute discretion so as to best enhance the Red Rooster System and the Red Rooster Image.
- (2) As at the date of this Agreement, We will contribute any promotional allowances to the advertising funds specified in clause 21 in Our absolute discretion however We may later use or apply such promotional allowances elsewhere in Our absolute discretion.

7.7 Collection of Amounts due to Suppliers

- (1) If requested You must pay to Us upon demand any amounts which are due and payable to suppliers of the Business.

- (2) Where We collect such amounts We will within a reasonable time remit such amounts to the appropriate supplier.
- (3) You must otherwise implement and maintain at all times a direct debit facility with such suppliers to Your Business as We may nominate from time to time.

Glossary of terms

- (3) **"Approved Supplier"** means a supplier who is approved in writing by Us for the supply to You of the Secret Products, the Non-secret Products, the Branded Products, the non-branded products and/or any other products, goods or services as may be specified by Us.
- (4) **"Brand Name"** means the name "Red Rooster".
- (5) **"Branded Products"** means products packaged by suppliers specifically for Us as "Red Rooster" products.
- (6) **"Business"** means the Franchise business of conducting a "Red Rooster" store.
- (7) **"Commencement Date"** means the Commencement Date of the Term set out in the Schedule.
- (8) **"Franchise"** means subject to the terms of this Agreement the non-exclusive Franchise and right which We grant to You to conduct the Business at the Premises using the Brand Name, the Marks and the Red Rooster System in accordance with this Agreement and the Manuals on and from the Commencement Date for the Term.
- (9) **"Franchisee"** means an authorised Franchisee whom We appoint to operate a Red Rooster store.
- (10) **"Food Products"** means barbecued chicken, deep fried chicken and chicken pieces, fish and other prepared foods and drinks.
- (11) **"Goodwill"** means the difference between the fair market value of the Business and the fair market value of the net tangible assets of the Business, such amount being the amount for which the net tangible assets of the Business could be exchanged between a knowledgeable and willing buyer and a knowledgeable and willing seller in an arms length transaction.
- (12) **"Manuals"** means the Manuals that We develop from time to time during the Term (including but not limited to papers, books, binders, videos, CD Rom and other methods of transfer of information such as electronic formats) and which contain details of the confidential and compulsory specifications standards and procedures regarding matters such as workplace health and safety, advertising, marketing and promotion, customer relations, equipment maintenance and replacement, product and service sales procedures, administrative, bookkeeping and accounting procedures which We set for the operation of the Business and the maintenance of the Red Rooster System and the Red Rooster Image as amended by Us from time to time at Our sole discretion including but not limited to the Confidential Operations Manual.
- (13) **"Marks"** means Our trade Marks, service Marks, business names and trade names set out in the Schedule.
- (14) **"Non-secret Products"** means all Branded Products and other products, ingredients, packaging and like goods used in the Business other than Secret Products.

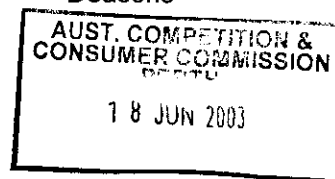

- (15) **"Premises"** means subject to clause 4.1, the Premises specified in the Schedule.
- (16) **"Principal"** means the Principal named as such in the Schedule.
- (17) **"Red Rooster Image"** means Our standards and specifications from time to time for design, layout, colour, Food Products and service and other elements of the Red Rooster System.
- (18) **"Red Rooster System"** means the comprehensive food retail sales system developed by Us including techniques for the sale of the Food Products under the Brand Name, proprietary rights in certain valuable trade Marks, service Marks and trade names including the name "Red Rooster", designs, colour schemes and layouts for business Premises, signage, equipment layouts, methods of operation, cooking techniques, products and Manuals covering business practices and policies and the use of certain unique recipes and formula in the preparation of the Food Products.
- (19) **"Schedule"** means the Schedule to this Agreement.
- (20) **"Secret Products"** means Our secret spice concentrate, seasoning mixture and breading spice concentrate.
- (21) **"Term"** means the Term of this Agreement set out in the Schedule including any renewal or extension and subject to the terms and conditions applying to earlier termination in this Agreement.
- (22) **"We", "Our" or "Us"** includes any of Our related companies, any successor or predecessor in title to Us and any of Our servants or agents.
- (23) **"You" or "Your"** means the Franchisee named as such in the Schedule."
- 3. (a) Class or classes of persons to which the conduct relates**
- Franchisees who are granted a franchise to conduct the business of a Red Rooster store in accordance with the terms and conditions of the franchise agreement.

The prescribed period is 21 days (if this notification is given on or before 30 June 1996) or 14 days (if this notification is given after 30 June 1996), starting on the day when this notification is given.

If the Commission gives a notice under subsection 93A (2) of the Act within the prescribed period, this notification will not come into force unless the Commission, after completing the procedures in section 93A of the Act, decides not to give a notice under subsection 93 (3A) of the Act. The notification comes into force when that decision is made.

If this notification is in respect of conduct of a kind referred to in subsection 47 (2), (3), (4) or (5), or paragraph 47 (8) (a) or (b) or (9) (a), (b) or (c), of the Act, it comes into force when it is given.
