# Application for Authorisation A90872 lodged by the Australian Stock Exchange in relation to Section 2 of the ASX Business Rules

The Australian Competition and Consumer Commission ('the Commission') has received an application for authorisation A90872 from the Australian Stock Exchange (ASX) in relation to section 2 of the ASX Business Rules. Section 2 of the ASX Business Rules govern the operation of the Stock Exchange Automated Trading System (SEATS) for the trading of securities in the stock market conducted by the ASX.

#### The Commission's role

By way of background, the Commission is the Commonwealth agency responsible for administering the *Trade Practices Act 1974* ("the Act"). A key objective of the Act is to prevent anti-competitive conduct, thereby encouraging competition and efficiency in business, resulting in a greater choice for consumers in price, quality and service.

The Act, however, recognises that the public interest may not always be met by the operation of competitive markets. The authorisation process in the Act addresses this eventuality by allowing the Commission to grant immunity from the application of many of the restrictive trade practices provisions of the Act in certain circumstances. In order to grant authorisation the Commission must be satisfied that the public benefit arising from the particular conduct outweighs any anti-competitive detriment arising from the conduct.

In assessing the public benefits and detriments of an authorisation application, the Commission undertakes a public consultation process seeking comments on the application from interested parties.

# ASX's current application

On 16 May 2003, the ASX lodged an application for authorisation relating to Section 2 of the ASX Business Rules which govern the operation of the SEATS.



The ASX has advised it is currently reviewing and where necessary re-drafting its operating rules (including Section 2 of the Business Rules) to comply with the terms of its licence and the March 2002 amendments to the Corporations Act. The ASX submitted that this review process and the lodging of the rules for approval with the Australian Securities and Investment Commission (ASIC) is likely to take place by October 2003.

The ASX has requested that the Commission grant interim authorisation in respect of the current application and then defer consideration of the substantive application until the review process is completed and it is able to provide the Commission with a final version of Section 2 of the Business Rules.

If granted, interim authorisation enables the applicant to engage in the conduct without breaching the competition provisions of the Act while the Commission considers the merits of the substantive application.

The ASX has submitted that no material changes have been made to Section 2 of the Business Rules since authorisation was granted by the Commission in 1998.

#### ASX's 1998 authorisation

On 1 April 1998, the Commission granted conditional authorisation to the ASX in respect of Section 2 of its Business Rules. This authorisation expired on 23 April 2003. The condition provided that authorisation for Rule 2.2.9 only would not come into force until the Commission advised the ASX that it was satisfied that the Business Rules were amended to include provisions for appeal to the Appeal Tribunal in relation to decisions by the ASX Board to reject, suspend or withdraw an application for a Designated Trading Representative. Rule 2.2.9 was not amended in this manner and accordingly was not covered by the 1998 authorisation.

# Commission's consideration of the request for interim authorisation

The Commission has considered the ASX's current request for interim authorisation and has decided to grant interim authorisation to Section 2 of the ASX Business Rules. However, interim authorisation does not extend to Rule 2.2.9 of the Business Rules as this rule does not appear to have been amended in line with the condition specified in the Commission's 1998 final determination.

The granting of interim authorisation will enable the status quo to continue while the ASX finalises its review and is in a position to provide the Commission with any amendments made to Section 2 of the Business Rules for which final authorisation will be sought.

The Commission's decision in relation to interim authorisation should not be taken to be indicative of whether or not final authorisation will be granted by the Commission.

The Commission has granted interim authorisation until such time as it issues its draft determination on the substantive application for authorisation, at which time interim authorisation will be reconsidered.

## The status of Rule 2.2.9

ASX has advised that it intends to clarify the appeal procedure in Rule 2.2.9 by amending the Business Rules in the next round of changes. ASX has advised that in the meantime, a compliance procedure will be built into the Business Rules to ensure that natural justice will be afforded to a Trading Participant affected by an adverse decision made under Rule 2.2.9.

# Commission's consideration of the substantive application

As requested by the ASX the Commission will defer its consideration of the substantive application until the ASX is able to provide it with a final version of Section 2 of the Business Rules. Accordingly, the Commission will begin its public consultation process with interested parties once it has received a final version of the Business Rules.
