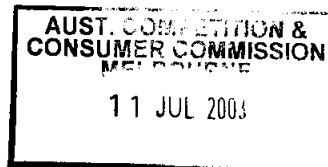

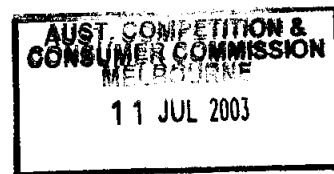

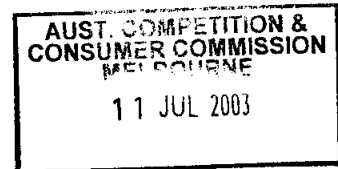

**SUBMISSION TO AUSTRALIAN COMPETITION AND CONSUMER COMMISSION IN SUPPORT OF NOTIFICATION UNDER SECTION 93(1) OF THE *TRADE PRACTICES ACT* 1974 (CTH)**

**1. Conduct**

This submission is in support of a notification lodged under section 93(1) of the *Trade Practices Act* 1974 (Cth) in relation to conduct potentially falling within sections 47(6) or (7) of the *Trade Practices Act*. Accordingly, the relevant test to be applied by the Commission is set out in section 93(3A) of the *Trade Practices Act*, whereby the Commission assesses whether the public benefits associated with the relevant conduct outweigh any likely public detriment.

Origin Energy Ltd ("Origin Energy") is a vertically integrated energy company, with activities in exploration and production, gas, electricity and LPG retail and trading, as well as in distribution network management.

Origin Energy retails electricity in Victoria through Origin Energy Electricity Ltd ("ElectricityCo") and gas in Victoria through Origin Energy (Vic) Pty Ltd ("GasCo").

Origin Energy has been examining additional methods to deliver increased value to customers and wishes to do so by providing rewards to those customers who choose to enter into a market contract for both electricity and gas with Origin Energy.

To this end, GasCo propose to pay certain of its customers who enter into market contracts with both GasCo and ElectricityCo a rebate on their gas bills on the first anniversary of the date of the relevant market contracts so long that the customer remains a customer of both companies for 12 months.

In offering a rebate, Origin Energy seeks to establish customer goodwill at a time of high competition. As one economic entity Origin Energy seeks to strengthen the commercial relationship with its customer base.

As one economic entity Origin Energy also seeks to enhance the brand awareness of its brand names.

**2. Public benefit**

The proposed conduct will result in the following public benefits.

The customers of ElectricityCo and GasCo will have the opportunity to purchase gas with the benefit of a \$30 rebate.

Apart from the benefits for the customers, the offer will also lead to (even) more competition and innovation in the competitive energy market.

For example, the offer may lead to competitive responses by other energy retailers which in turn would lead to lower prices and a greater variety of products also for non-Origin Energy customers.

3. **No Public detriment**

The proposed conduct will not result in public detriment.

The offer of a rebate to GasCo and ElectricityCo customers has no detrimental side-effects for either the GasCo or ElectricityCo customers or the general public. Also, the rebate offer will have no detrimental effects for customers of other energy retailers, or the general public. Rather, it is likely that the rebate offer will prompt a competitive response from Origin Energy's competitors to the benefit of the customers and the general public.

4. **Conclusion**

The proposed rebate offer will result in substantial public benefits. In particular, it will have a pro-competitive effect in the energy markets. The rebate offer will have no off-setting detrimental effects for the Origin Energy customers or the general public.
