Internet Services, TEDIS, Leadtec, ABS, Pacific Commerce and ECEnable. GE ecXpress was chosen by GHA out of a number of EDI Service providers following a competitive evaluation process.

EDI services are generally billed on a per document or per kilo character basis. Under the GHA plan, the total number of documents sent by GHA members will be aggregated each month. The number of documents sent by the community in the month will determine the price per document that will be charged to each member of the community for that month. As the number of documents increases, the price per document for each member will decrease. The proposed pricing contemplates progressive decreases in the per document fee at various volume levels. Overall the price decreases by approximately 58%. GE ecXpress will also offer GHA members a 10% discount on the standard list price of GE ecXpress's Integrator 4 software and other EDI Software Products.

GHA members are under no obligation to take GE ecXpress services. GHA members who have an existing relationship with GE ecXpress or who are eligible for other plans offered by GE ecXpress, may choose whether they wish to take advantage of the GHA plan or use another available plan.
