As you may recall from our discussion of 26 February 2004, I noted that once the Commission had received the information from you clarifying what Holden Ltd was seeking to notify, the Commission would then conduct its assessment of the notification with all of the information before it. I noted that, generally speaking, where the Commission does not have concerns regarding conduct which is notified, the Commission will provide a letter to the notifying party (or their legal representative) to the effect that the Commission did not intend to take any further action at the time.

The Commission is yet to finalise its assessment of the matter. Once the assessment is finalised, the Commission will contact you regarding the outcome.
