Review of Notification of Exclusive Dealing (N30710) - James Hardie and Coy Pty Ltd

I refer to the above notification (copy attached) lodged by James Hardie and Coy Pty Ltd (James Hardie) in February 1995 with the then Trade Practices Commission (TPC), predecessor to the Australian Competition and Consumer Commission (the Commission).

The notified conduct relates to James Hardie supplying or refusing to supply fibre cement products to CSR on condition or for the reason that CSR will not re-supply or has not agreed not to re-supply fibre cement products to distributors/re-sellers in any State or Territory in Australia except for Western Australia and the Northern Territory.

On 3 March 2004 the Commission wrote to James Hardie Australia indicating that the Commission had decided to review the notification. James Hardie Australia subsequently replied to the Commission advising that James Hardie and Cov Ptv Ltd (now known as Amaca Pty Ltd), is no longer part of the James Hardie Group of companies and is not within the control of James Hardie Australia Pty Ltd.

Furthermore, in the course of the review, the Commission has received information to the effect that Amaca is no longer involved in the manufacture and supply of fibre cement products.

The Commission requests Amaca to confirm that:

- 1. Amaca is no longer part of the James Hardie Group of companies and is not within the control of James Hardie Australia Pty Ltd;
- 2. Amaca is no longer involved in the manufacture and supply of fibre cement products;
- 3. Amaca no longer participates in the conduct the subject of the notification as mentioned above.

Section 93(1) Notification

- 1. We attach a notice pursuant to section 93(1) of the Trade Practice Act 1974. The following information may also be relevant, although it is not exhaustive.
- James Hardie & Coy Pty Limited ("James Hardie") has been supplying fibre cement building products to CSR Limited ("CSR") or CSR owned outlets for approximately 3 years.
- 3. CSR, Boral Limited and Pioneer Limited, as well as other local and overseas suppliers, manufacture and or supply products competitive with the James Hardie fibre cement products supplied to CSR owned outlets.
- Fibre cement products are manufactured overseas and suppliers such as Eternit and Humes (both Malaysia) have exported product into Australia.
- 5. CSR has announced it will itself manufacture and supply fibre cement products by early 1996.
- 6. Possibly twenty six CSR owned outlets trading as "Gyprock Plaster Lining Centres" are likely to be affected by the notified conduct, although the number may be less than twenty six. They are located in New South Wales, Queensland, Victoria and Tasmania.
- 7. In addition to selling James Hardie fibre cement products, CSR owned outlets typically sell a range of "Gyprock" plasterboard products, "Bradford" insulation products, decorative cornices, plaster and fixing accessories, and related products.
- 8. In each of the regions in which the CSR owned outlets are located, there are other outlets stocking James Hardie fibre cement products.
- 9. Of James Hardie's total sales of fibre cement products in Queensland, New South Wales, Victoria and Tasmania, purchases by CSR in those States represent some confidentiality.
- 10. The percentage figure contained in paragraph 9 above is confidential and accordingly the Grande Commission is asked to exclude it from the register kept under subsection 95(1) of the Trade Practices Act by reason of its confidentiality.
