**Authorisation applications lodged by Qantas Airways Limited & British Airways PLC
(A30226 and A30227)**

The Australian Competition and Consumer Commission (ACCC) has considered an application for authorisation lodged by Qantas Airways Limited (Qantas) and British Airways PLC (BA) in relation to a restated Joint Services Agreement dated 3 April 2000 between Qantas and BA and related and consequential coordination of schedules and pricing between the parties (A30226 and A30227).

The ACCC has issued a draft determination proposing to grant authorisation for the above arrangements for a period of five years. A copy of the Commission's draft determination is enclosed for your information.

In accordance with section 90A of the *Trade Practices Act 1974*, you may notify the ACCC in writing by close of business on **6 September 2004** if you wish the ACCC to hold a pre-determination conference in relation to the draft determination.

A pre-determination conference provides the opportunity for interested parties, particularly in the event they are dissatisfied with the ACCC's draft determination, to make an oral submission in response to the ACCC's draft determination. In the event of such a conference taking place it would be held as soon as possible, but in any event, no later than **6 October 2004**.

If you wish to make a written submission in respect of the draft determination, this should be forwarded to the ACCC no later than **20 October 2004**.



On 11 June 2003, the ACCC granted interim authorisation in relation to the abovementioned applications for authorisation until such a time that the ACCC makes a draft determination in respect of the applications. The ACCC indicated that it would review the appropriateness of continuing interim authorisation at that time.

The ACCC has decided to continue interim authorisation until such a time that the ACCC makes a final determination in respect of the applications.
