

GrainCorp Operations Limited and AWB Limited - Applications for authorisation

Mallesons Stephen Jaques acts for GrainCorp Operations Limited ("GrainCorp") and Export Grain Logistics Pty Limited ("JVCo") and Mr Bill Reid of Blake Dawson Waldron acts for AWB Limited ("AWB") in this matter.

- 1 Applications for authorisation
- 1.1 GrainCorp, AWB and JVCo (together "the Parties") apply for authorisation pursuant to sub-sections 88(1), 88(8) and 88(9) of the *Trade Practices Act 1974* (Cth) ("TPA") for:

3 Timeframe for determination

For the purposes of section 90(12) of the TPA, the Parties agree that the Commission may take a longer period for the determination of the application for authorisation of a merger under section 88(9) of the TPA such that the matters may be considered by the Commission together, particularly given that interim authorisation is being sought for the reasons set out in the supporting submission.


