Third line forcing notifications - FAL nominated supermarkets - BP, Caltex and Peak service stations - sale of discount fuel in Perth

We enclose three third line forcing notifications in relation to the sale of discount petrol on behalf of:

- Koondoola Service Centre Pty Ltd (ABN 60 009 252 206) ("Koondoola") which
 operates Caltex service stations in the Perth metropolitan area;
- White Gum Petroleum Pty Ltd (ABN 61 074 507 074) ("White Gum") which operates Peak service stations in the Perth metropolitan area; and
- Sanzone Nominees Pty Ltd (ACN 008 830 466) ("Sanzone") which operates BP service stations in the Perth metropolitan area.

We also enclose a cheque for \$300.00.

As set out in previous notifications, Foodland Associated Limited (ABN 13 008 667 650) ("FAL") has introduced a promotion in Western Australia whereby customers have the opportunity to purchase discounted petrol at participating service stations if the customers spend at least a specified amount at nominated supermarkets ("the Promotion").

FAL has now been approached by Koondoola, White Gum and Sanzone in relation to participation in the Promotion.

As detailed in the notifications, the fuel retailers believe the proposed conduct will result in a number of public benefits, will promote competition, and will not have any negative effect on competition in any relevant market.

While FAL is assisting each of the fuel retailers with the logistics of preparing and lodging the notifications, FAL wishes to confirm that it has had discussions with each of the fuel retailers individually, offering them the opportunity to participate in the Promotion. Each of the fuel retailers has agreed individually with FAL to participate. In particular, we are not aware of any

discussion or agreement among the fuel retailers with respect to entering into, or the terms of, the Promotion.

In addition, we confirm that each of the fuel retailers listed above has given written authorisation to Mr Peter Hede of FAL to sign the third line forcing notification on its behalf. Copies of these authorisations are attached.
