Re: South Australian Oyster Growers Association Inc. applications for authorisation A60024 and A60025 - interested party consultation

Introduction

The Australian Competition and Consumer Commission (the ACCC) is currently conducting an interested party consultation process in relation to applications for authorisation made by the South Australian Oyster Growers Association Inc. (SAOGA). As a possible interested party you are invited to comment on the issues outlined in this letter.

SAOGA has sought authorisation in relation to the imposition of a levy on purchasers of oyster spat sold for cultivation of oysters within South Australia.

Background

The ACCC is the Commonwealth agency responsible for administering the Trade Practices Act 1974 (the Act). A key objective of the Act is to prevent anti-competitive arrangements or conduct, thereby encouraging competition and efficiency in business resulting in a greater choice for consumers in price, quality and service.

The Act, however, allows the ACCC to grant immunity from legal action for anti-competitive conduct in certain circumstances. One way businesses may obtain immunity is to apply for what is known as an 'authorisation' from the ACCC. Broadly, the ACCC may 'authorise' businesses to engage in anti-competitive arrangements or conduct where it is satisfied that the public benefit from the arrangements or conduct outweighs any public detriment.

In assessing the public benefits and detriments of an authorisation application, the ACCC undertakes a public consultation process seeking comments on the application from interested parties. Following an initial consultation process, the ACCC will issue a draft decision for comment.



Application for authorisation by SAOGA

The ACCC has received applications for authorisation from SAOGA relating to an agreement between SAOGA and four oyster hatcheries, namely the South Australian Oyster Hatchery Pty Ltd, Cameron of Tasmania Pty Ltd, Shellfish Culture Ltd and ATF A.R.K. Fisheries Trust and M & I Securities Pty Ltd, trading as Geordy River Aquaculture Pty Ltd.

The agreement allows the South Australian Oyster Research Council (SAORC) to invest money levied on oyster growers in South Australia for the purpose of research and development. The levy is collected from all purchasers of oyster spat for cultivation within South Australia and hatcheries for oyster spat retained and cultivated within South Australia. The levy, currently \$1.00 per 1000 oyster spat, is set by SAORC.

The ACCC granted authorisation to similar arrangements in September 1999. This authorisation expired on 7 September 2004.

For details on the public benefits and detriments that SAOGA claims are likely to result from the proposed arrangements please see the attached submission.

Application for interim authorisation

SAOGA has also applied for interim authorisation in respect of these arrangements. If granted, interim authorisation will enable the parties to engage in the arrangements while the ACCC considers the merits of the substantive application for authorisation. By its nature, the ACCC is required to consider a request for interim authorisation very quickly and so only a short consultation period is available. The ACCC is not required to make a decision on the merits of the application for authorisation in reaching its decision on a request for interim authorisation, but would look at factors such as the urgent need for exemption of the arrangement and harm likely to result to the applicant and interested parties should interim authorisation be granted/denied.

Request for submissions

To assist the ACCC in its consideration of the applications it would be helpful to obtain your comments on the likely public benefits and the likely effect on competition, or any other public detriment, from the proposed arrangements.

The ACCC asks for submissions to be in writing so they can be made publicly available. They are placed on a public register for this purpose.

Persons lodging a submission with the ACCC may request that information included in the submission be treated as confidential and not placed on the public register. If confidentiality is granted in respect of information the ACCC may take it into account, even though it is not publicly available. Guidelines for seeking confidentiality are attached.
