Royal Australian Institute of Architect's application for revocation and substitution

I refer to your correspondence of 14 March 2005. Department's response to your questions under 'your views are sought' is as follows:

- The New South Wales Department of Housing procures architectural design services through a select tender process from an internal register.
- The names of the individuals (sole practitioners) and firms whom we have employed during the last five years are provided in the Attachment.
- The Department pre-qualifies architects by ensuring that they are registered with the Board of Architects NSW and consequently, are entitled to practise as architects, under the terms of the Architects Act 2003.
- The building design fee is determined by the market. It is not based on fee guidance information from the Royal Australian Institute of Architects, or any other provider of building design services. Based on their skills and experience, selected architects are invited to submit a fixed fee quotation for the required service and the work is awarded after a predetermined assessment process.
- The Department ensures that the registered architects are provided with equal opportunities to quote subject to satisfactory previous performance.

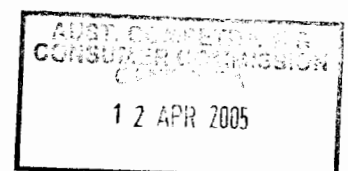
