

Nathalia Supermarket Pty Ltd, is proposing to offer a fuel deal to the township of Nathalia.

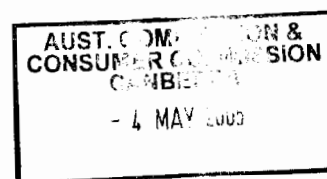
