Re: South Australian Oyster Growers Association Inc. applications for authorisation A60024 and A60025 - interested party submission

I refer to the above applications for authorisation lodged with the Australian Competition and Consumer Commission (the ACCC) on 25 February 2005 and 11 March 2005 respectively and amended on 5 April 2005.

As you are aware, on 5 April 2005 the ACCC wrote to interested parties seeking submissions in relation to the applications. The ACCC requested submissions be provided by 29 April 2005.

The ACCC has received one submission from Ms Vicki Blesing and a copy this submission is attached for your information and/or comment. This submission is also posted on the ACCC internet site at <www.accc.gov.au>.

In addition, to assist the ACCC in its consideration of the applications, I would appreciate the following additional information from SAOGA in relation to the operation of the levy:

- The amount of money collected by SAORC under the levy each year since its 1. establishment.
- 2. Specific details of the distribution of monies raised to fund the research and development projects identified in SAOGA's submission in support of its applications for authorisation (i.e. amounts spent on each project).
- 3. Details of any other projects, or SAORC operations more generally, funded by the levy, including the amount of funding provided by the levy.



- 4. To the extent currently known, specific details of how it is intended that the monies raised by the levy in the future will be spent (i.e. ongoing or planned projects intended to be funded by the levy).
- 5. Details of instances, if any, where growers have sought refunds of levies paid.

Please provide this additional information, along with any comments you may wish to make in relation to the submission, by **cob Friday 29 May 2005**, in order that the ACCC may progress its consideration of this matter.
