## Applications for revocation of authorisation A90745 and substitute by replacement authorisation A90972 lodged by Premium Milk Ltd

I refer to the application for revocation of authorisation A90745 and substitute by replacement authorisation A90972 made by Premium Milk Ltd (Premium) to the Australian Competition and Consumer Commission (ACCC).

You may recall that, as part of their application, Premium requested that the ACCC grant interim authorisation to allow it, on behalf of the dairy farmers it represents, to continue collectively negotiating with Parmalat Australia Ltd (Parmalat) and to give effect to the arrangements after the expiry of A90745 on 30 June 2005, while the ACCC considers the merits of the substantive application (A90972).

## ACCC considerations

The ACCC has considered the request for interim authorisation and has decided to grant interim authorisation until it issues a determination in this matter (unless circumstances warrant revocation or amendment of the interim authorisation at an earlier stage).

Accordingly the ACCC has suspended the operation of authorisation A90745 and has granted interim authorisation to the application in substitution (A90972) on the same terms as those originally authorised.

In assessing the request for interim authorisation the ACCC considered that interim authorisation would maintain the status quo in the relevant market(s) while it considers Premium's substantive application. The ACCC has also noted that the authorised arrangements (collective bargaining) have been operating for some time, and in these circumstances considered that the denial of interim authorisation may cause marketplace disruption, particularly if the ACCC were to ultimately grant authorisation.



Please be advised that the ACCC's decision in relation to interim authorisation should not be taken to be indicative of whether or not final authorisation will be granted by the ACCC.

Next steps

For your information, the next step in the process is for the ACCC to release a draft determination which will take account of any submissions from Premium and interested parties and will indicate the ACCC's preliminary views on the merits of the application. The ACCC will provide both Premium and interested parties with the opportunity to provide a further submission on the draft determination before the ACCC issues its final decision.
