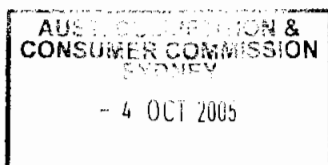

We enclose a cheque for \$200 on behalf of Integral Energy being the concessional fee for a related notification.

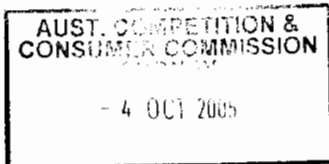
