Third line forcing notifications N31439 (VISA) and N31440 (Ticketek)

We refer to your letter of 16 September 2005. We also refer to Ticketek's letter to you of today's date.

In the case of each offer which will be the subject of the proposed arrangement with the ACCC, Ticketek is likely to be better placed to inform the ACCC in relation to the details of the offer. Any information which would be provided by VISA to the ACCC would most likely be provided by Ticketek to VISA for that purpose.

As Ticketek has agreed to provide (in substance) the information which has been requested by the ACCC, we assume there is no need for VISA to provide the same information in relation to each offer.

Please let us know if this approach is acceptable to the ACCC.
