Potential Third Line Forcing Conduct

We act for Australian Local Search Pty Ltd (ALS).

We have been instructed to lodge a Form G Exclusive Dealing Notification in relation to potential third line forcing conduct by ALS under the *Trade Practices Act 1974* (Cth) *(the Act)*. We enclose the notification filing fee of \$100.

ALS operates an online advertising website and proposes to offer online advertising services with the offer of additional benefits to customers who have also purchased print advertising from a specified third party.

ALS submits that in relation to the statutory test under s93(3A), no public detriment will result from the conduct, but instead there will be clear public benefits. The offer encourages businesses to expand the types of media through which they advertise by promoting the use of online advertising. This benefits the ultimate consumer by increasing the avenues through which information regarding goods and services can be obtained. For many consumers, comparing goods and services on the internet is more convenient than other methods.

ALS sets out further details and submissions regarding the proposed conduct in the Confidential Annexure. ALS requests that the Commission exercise its discretion under s95 of the Act to exclude the Confidential Annexure from the public register until the offer has been officially launched. Considerable time and resources have been spent developing the offer and ALS is concerned that it will lose its first mover advantage if details are released prior to its official launch. If the Commission does not grant ALS's request for confidentiality, we request that you return the Confidential Annexures to ALS pursuant to s95(4) of the Act and not include them on the register.
