

EXCLUSIVE DEALING NOTIFICATION

To the Australian Competition and Consumer Commission:

Notice is hereby given, in accordance with sub-section 93(1) of the *Trade Practices Act* 1974, of particulars of conduct or of proposed conduct of a kind referred to in sub-section 47(2), (3), (4), (5), (6) or (7), or paragraph 47 (8) (a), (b) or (c) or (9) (a), (b), (c) or (d), of that Act in which the person giving notice engages or proposes to engage.

1. (a) Name of person giving notice

Caltex Petroleum Services Pty Ltd ACN 005 632 860 trading as Caltex Sydney (Caltex Sydney).

(b) Short description of business carried on by that person

Caltex Sydney conducts business as a reseller of Caltex petroleum products and also operates service stations under the Caltex and Ampol brands within metropolitan Sydney. Caltex Petroleum Services Pty Ltd is a wholly owned subsidiary of Caltex Australia Petroleum Pty Ltd. Its ultimate holding company is Caltex Australia Limited. The notified conduct relates to a recently acquired service station in Camden NSW which is now operated by Caltex Sydney.

2. (a) Description of the goods or services in relation to the supply or acquisition of which this notice relates

This notice relates to the supply of fuel by Caltex Sydney from its service station at 21 Barsden Street, Camden NSW.

(b) Description of the conduct or proposed conduct

Caltex Sydney proposes to supply discounted fuel (including petrol, diesel and LPG) to customers of the Caltex branded service station located at 21 Barsden Street, Camden NSW (*Camden Service Station*) on condition that they acquire certain services from J Martin & P Martin Family Partnership trading as Taplins Automotive Repairs (*Taplins*), which conducts business as a mechanic at 28 Edwards Street Camden NSW 2570.

Specifically, Caltex Sydney will offer to supply to customers of Camden Service Station at a discount (presently 5.0 cents per litre) (*Fuel Discount*) on all fuels purchased (including petrol, diesel and LPG) if they:

- (i) have their cars serviced by Taplins for not less than a specified service value (presently nil) (third party purchase); and
- (ii) purchase petrol, diesel or LPG in a single transaction of not greater than a specified volume (presently uncapped) from Camden Service Station within 30 days after the date of the third party purchase.

Customers who have had their car serviced by Taplins receive a voucher from Taplins which can then be redeemed at the Camden Service Station within 30 days after the date of issue. When the voucher is redeemed by Caltex, a copy of the sales receipt (which shows the volume of fuel sold) is attached to the voucher. On a monthly basis Caltex Sydney will invoice Taplins for reimbursement of part of the Fuel Discount, currently amounting to 4.0 cents per litre. The invoice includes a summary of the volume of fuel sold to customers who have purchased fuel using the discount voucher issued by Taplins.

Current and future customers of Taplins who also purchase fuel from Camden Service Station.

NOTICE

If this notification is in respect of conduct of a kind referred to in sub-section 47(6) or (7) or paragraph 47(8)(c) or (9)(d) of the *Trade Practices Act* 1974 ("the Act"), it comes into force at the end of the period prescribed for the purposes of sub-section 93(7A) of the Act ("the prescribed period") unless the Commission gives a notice under sub-section 93A(2) of the Act within the prescribed period, or this notification is withdrawn.

The prescribed period is 21 days (if this notification is given on or before 30 June 1996) or 14 days (if this notification is given after 30 June 1996), starting on the day when this notification is given.

If the Commission gives a notice under sub-section 93A(2) of the Act within the prescribed period, this notification will not come into force unless the Commission, after completing the procedures in section 93A of the Act, decides not to give a notice under sub-section 93(3A) of the Act. The notification comes into force when that decision is made.

If this notification is in respect of conduct of a kind referred to in sub-section 47(2), (3), (4) or (5), or paragraph 47(8)(a) or (b) or (9)(a), (b) or (c), of the Act, it comes into force when it is given.

Submission

The notified conduct is similar to conduct which has already been authorised by the ACCC on previous occasions. In particular, the ACCC has authorised the Caltex/Woolworths and Shell/Coles shopper docket discounts and determined that such arrangements have resulted in an overall net public benefit. The notified conduct is also likely to result in a net public benefit.

The notified conduct is unlikely to result in any public detriment. The conduct relates to one particular Caltex service station at Camden and one particular mechanic at Camden.
