## Form 3G Exclusive Dealing Notifications for Lion Nathan promotion

We act for Lion Nathan Australia Pty Limited (ABN 1300 859 6370). Our client proposes to make a promotional offer with Alpha, a magazine publication owned by News Limited.

The January edition of Alpha will contain a voucher which can be used to redeem a free bottle of Hahn Super Dry from BWS liquor stores. To redeem the Hahn Super Dry, all that will be required is an original copy of the voucher. It is not necessary for the bearer of the voucher to show that he or she had purchased a copy of Alpha.

While our client and ourselves think there is a legitimate view that the short-term promotional offer does not constitute third line forcing, our client has nevertheless instructed us to submit a Form G Exclusive Dealing Notification under section 93(1) of the Trade Practices Act 1974 in respect of the promotional offer. The conduct described in the Exclusive Dealing Notification includes the promotional offer and other conduct similar to the promotional offer that Lion Nathan may wish to engage in with the proprietors of Alpha or other media proprietors from time to time up to 31 January 2008.

To the extent the conduct described involves third line forcing, we submit that the conduct does not and is not likely to result in a detriment to the public. On the contrary, we submit that the use of vouchers in the manner described is a feature of competitive markets. It also serves to expand, rather than restrict, the supply of beer products at effectively reduced average prices. Accordingly, the conduct described would likely be of benefit to the public.

We enclose a cheque for \$100 as payment of the statutory fees.
