Application for authorisation A91007 – final determination**

The Australian Competition and Consumer Commission (the ACCC) has issued a determination granting authorisation to the application lodged by COMPS on 12 July 2006. A copy of the ACCC's determination is attached. The ACCC has decided to grant authorisation for the reasons set out in its determination until 28 February 2009.

*Application for review*

Pursuant to section 101 of the *Trade Practices Act 1974*, a person dissatisfied with this determination may apply to the Australian Competition Tribunal for its review. An application for review must be made within 21 days of the date of this determination; that is, on or before **3 January 2007**. If no application to review is lodged by this date, the ACCC's determination will come into force on **4 January 2007**.
