- We note that Bayside City Council, Brimbank City Council, Darebin City Council and Knox City Council were not listed in Schedule 1 to the submission attached to the applications. However, pursuant to section 88(13) of the *Trade Practices Act 1974* (C'th), these applications for authorisation were also expressed to be made in relation to other contracts, arrangements or understandings or proposed contracts, arrangements or understandings that are or will be in similar terms. The participation of these Councils in the tender process will result in proposed contracts, arrangements or understandings on similar terms to that subject to these authorisation applications.
- The councils listed at paragraph 5(b) of the applications are the councils who currently have a contract with a bus shelter provider but may opt in to the proposed arrangements at a later date once their existing contracts have terminated. The names of the councils now participating in the tender that were not included in Schedule 1 to the submission, were not listed at paragraph 5(b) because, based on our instructions at the time the application was made, they had not indicated an intention to participate to MAV.
- We are advised by the Department that some councils may choose not to make a decision concerning their participation in the Department's process until the terms and conditions of the supply of bus shelters, including price, are finalised.
