Collective bargaining notifications CB00001 and CB00002 lodged by Queensland citrus growers on 31 July 2007 - interested party consultation

The Australian Competition and Consumer Commission (the ACCC) has received two collective bargaining notifications (within the one form) from three Queensland citrus growers who propose to collectively negotiate the price and volume of their supply of citrus fruit to Woolworths Limited and IGA Distribution Limited.

The ACCC invites you to comment on the notifications. Enclosed is a summary of the collective bargaining notification process.
