## Collective bargaining notification CB00003 lodged by the Australian Newsagents Federation - interested party consultation

The Australian Competition and Consumer Commission (the ACCC) has received a collective bargaining notification from the Australian Newsagents Federation (ANF). The ANF proposes to negotiate contracts on behalf of its Western Australian members with Western Australian Newspapers (WAN).

The ACCC invites you to comment on the notification. Enclosed is a summary of the collective bargaining notification process.

## Request for submission

The ACCC will progress its assessment of the notification in a timely manner. An indicative timetable is set out below for your information.

20 August 2007	Lodgement of notification and supporting submission completed.
20 August 2007	Public consultation process begins.
31 August 2007	Closing date for submissions from interested parties
7 September 2007	Notifying parties respond to issues raised in the public consultation process.
On or before 14 September 2007	ACCC releases its assessment of the notification
17 September 2007	Absent ACCC objection, protection afforded by the collective bargaining notification comes into effect.
