## Collective Bargaining Notifications CB00059 to CB00066 lodged by Australian **Independent Record Labels Association** - interested party consultation

I refer to the above collective bargaining notifications lodged with the Australian Competition & Consumer Commission (ACCC) by the Australian Independent Record Labels Association (AIR).

AIR proposes to collectively bargain, on behalf of participating members, with each of Telstra, Optus, BigPond, Austar, Foxtel, MTV Networks, XYZ Networks and Fuel TV in relation to licensing of its members' audio and visual rights in respect of public performance and transmission of music videos.

The ACCC considers that notifications CB00059 to CB00066 were effectively lodged on 15 December 2008. While completed forms and payment were received on 9 December 2008, AIR advised that the attachment to the forms providing evidence of members' consent to the applications being lodged on their behalf, provided on 9 December 2008, was a draft that had not been provided to AIR members for the purpose of obtaining their consent. AIR subsequently provided the correct consent form to the ACCC on 15 December 2008.

Accordingly, the ACCC considers the notifications to be validly lodged on the date AIR provided evidence of participating members' consent to the applications being lodged on their behalf, which was 15 December 2008.

I also note that Attachment Two to the Form GAs contains a list of 63 participating members. Company names, contact details and addresses are provided for 61 members. For two other members only an email address is provided. AIR has advised that as it has been unable to provide company names and addressed for these two parties it is happy for the collective bargaining group notifications to be considered as being lodged on behalf of the 61 members for whom names and addresses have been provided. Accordingly, the ACCC considers the notifications to be validly lodged on behalf of these 61 members.

## Interested party consultation

Please find **attached** a copy of the letter that was sent to interested parties, together with a summary of the collective bargaining notification process. Other documents concerning the notifications will be made available on the pubic registers section of the ACCC's website: <a href="http://www.accc.gov.au">http://www.accc.gov.au</a>.

Submissions, including oral comments, will be placed on the ACCC's public register, subject to any request for exclusion.

Absent ACCC objection, legal immunity conferred by the notifications will commence on **Monday**, 12 January 2009.
