Dear Monica,

Firstly thank you for the opportunity to submit on behalf of the members of National Dirt Racers Association – WA Branch, information which may help the decision of the ACCC in refusing the application lodged by NASR Pty Ltd on behalf of themselves and other parties.

To answer question 1 of your letter is very easy. Our drivers do not feel it is necessary to have a NASR license at all. They are quite happy to have either a NDRA license, or a license from their controlling division. In 2006 many complaints regarding having to have NASR licenses were forwarded to the Queensland Branch of the ACCC (copy of correspondence enclosed). These complaints were against the Motorplex here in West Australia. The main complaint is that drivers get absolutely no input into decisions made by a proprietary limited company. This is also evidenced by the list of names submitted by NASR in support of the application. Drivers were not aware such a submission had been presented to the ACCC and had not given permission for their names to be used in support. It was only by chance that information was found on the ACCC website regarding this submission. No clubs here in West Australia knew anything of this submission.

To answer question 2 – It is very easy to get insurance for motorsport both Personal Accident and Public Liability. In West Australlia, NDRA (SLE Insurance), Combined Insurance, Wesfarmers, Australian Speedway Accident Fund to name a few, all give Personal Accident cover. Public Liability is also supplied by Marsh through Advantage Jonston to many tracks in the West.

Many drivers who wish to race at the Motorplex have both NDRA and NASR insurance, as NDRA insurance (or any other for that matter) is not accepted there.



On the subject of Public Liability insurance – Marsh provide the same policy as they do to NASR, to many country tracks here, at a far less cost. I know of several cases where tracks have been asked to pay extra to have NASR Public Liability insurance to run a NASR approved meeting. This is ludicrous, and I am happy to say at least one track stood up and stated that their insurance was adequate and was in fact the same, and that if the division concerned did not want to accept that, they needn't bother turning up. Of course the speedway cancelled that meeting when the negotiators stood firm insisting on NASR insurance.

Also some think that 'off shore' insurance is still allowed in Australia to insure motorsport. All motorsport insurance MUST be APRA approved.

I would like to give a little background in to how NDRA came into being in WA. In 2004 a group of speedcar drivers who all had their own insurance due to business were told that they had to have NASR insurance to race in that division. A substitute body – NDRA was located and a public meeting held on 17<sup>th</sup> October, 2004. This meeting had representation from a wide section of the speedway fraternity.

One very interesting thing to come out of that meeting was a statement by the then Chairman of the Western Australian Speedway Commission, Mr Bob Biltoft regarding the charging of 'pit insurance'. He stated that the Commission had received legal advise saying that this practice had to stop immediately as it was illegal since 30<sup>th</sup> March, 2004. A letter to that effect was duly circulated to all speedways. Copy of letter and relevant information from that meeting enclosed.

Another interesting thing was the dissatisfaction with NASR, Drivers were seeking an alternative. A branch of NDRA opened in West Australia in December, 2004. To this date membership has spiraled, increasing heavily each year whish indicates that drivers and crews wish to have a choice.

On the 24<sup>th</sup> May, 2004 NASR sent out a letter stating that for the 2004/2005 season membership and licenses would be combined (copy enclosed). In that letter it stated the costs of the license fees and the insurance fees. At no time in that letter did it state that the insurance would be 'free' or a member benefit however when NDRA gained momentum the insurance was touted as being free and a member benefit!! This clearly was not true as the letter of May 2004 gave the break up of costs. Today the cost of a license for an AA driver is \$175 compared to \$150 in 2004. What has risen – the cost of the license or the cost of the insurance??? Or the cost of the other 'member' benefits maybe.

National Dirt Racers Association Incorporated is a not for profit organization run by drivers for drivers. In other words a 'drivers' union'. Monies raised by way of membership and licenses is given back to members by the way of prize money, provision of safety apparel for junior drivers, helping speedways in need of funds for insurance, trophies and tow money. Also supplying of log books, scrutineering sheets and rule books. Information sheets re safety issues, (such as schnell ratings) and monthly newsletters are also provided to members. All positions with NDRA are voluntary and persons travelling to country tracks do so at their own expense. NDRA have helped tracks with providing scrutineers, lapscorers, pit marshals and pit gate attendants just to name a few of the ways NDRA give back to the sport.

Drivers and crews in West Australia were very quick to set up a petition to send to the ACCC and to the Government asking that careful consideration be made in the granting of the 'exclusive dealing' applications. As the majority of tracks are Local Government owned and operated by clubs, drivers and crews felt that no speedway organization should have control over them, saying who can or cannot race there. They also stated on the petition that they were not aware any such applications had been sent to the ACCC and that they did not give permission for their names to be put on a public register. They also stated that they felt the granting of the application would be to the detriment of the sport of speedway racing. Drivers also stated that they felt that they should be able to utilize the facilities at the Motorplex ( a state government owned venue) even

though it was leased to Placide Pty Ltd – shareholders of NASR Pty Ltd.

It is very interesting to note that some of the interested parties listed in your letter, are in fact shareholders of NASR Pty., Ltd. A company search has been enclosed for your convenience. It is believed that some of these will be very vocal in their support for the applications as it is in their best interests to 'reap' the dividends.

In West Australia a Speedway Commission was set up by the Government. Unfortunately now NASR personnel are heavily involved with this commission. NASR Board member Rod Slater, is also the Chair of the commission. Des Alfirevich, Kevin Theyer, and Graham Winter – all Commissioners of the WA Speedway Commission, are all on the State Committee for NASR WA. The Secretary of the WA Speedway Commission is also a member of NASR's State Committee – Ms Marlene Criddle. A definite conflict of interest one would think.

We definitely need a governing body akin to the Victorian Speedway Council in this state. The VSC has successfully operated since 1971.

### NASR 2004/05 SEASON FEES AND PROCEDURES

#### 1. FAS Personal Accident Insurance

- · Standard level of sover is no longer available
- Pormer Delive level of cover now sole level of cover available but at charges see

#### 2 NASK Licence and Membership

- One fee now includes NASR Membership and Licence, FAS Personal Accident Insurance cover and NASR State fees.
- New licence category "V Vintage" for all vintage and classic drivers for demonstration purposes.

#### 3. Personal Academi Policy Document & Product Disclosure Statement (FDS)

Due to new the new Financial Services Reform Act, enacted in March 2004, every participant in the personal accident insurance scheme must now receive the Full Policy Wording and a FDS (as opposed to previously receiving a Summary of Benefits). These are lengthy documents, but we are now all required by Law to pass this on the end user with the application form. These documents are provided by the underwriter and it is suggested that all participants retain these documents.

(a) Medicale

ALL

All drivers are now required to include their completed medical form with their application form to the NASR National Office. This is subject to the NASR Privacy Policy which is available from NASR or on the NASR website.

#### 5. Vintage/Classic Drivers Licence & Medicals

It is preferred that Vintage and Classic drivers provide a medical although it is not mandatory. However, in the absence of a medical, drivers will be required to sign a Vintage/Classic Driver specific waiver/release of liability form that must be witnessed by a club licencing officer. These forms are available at the NASR National Office and must be returned to the NASR National Office with the Licence Application.

#### 6. Laic Fees

NASR recommends that all licence application forms including photo, medical (drivers only) and payment should be forwarded to the NASR National Office via their club at least three full weeks prior to meing. This will allow time for processing and return postage. For anyone wanting to fast track their licence through the office in order to race, a late fee of \$20 will apply per licence.

#### 7. Employed Junior Drivers and Mechanics

The NASR Junior licence and FAS Junior personal accident insurance does not provide for loss of wages under the scheme plan. Therefore those juniors who are employed must upgrade their licence to the appropriate senior level of personal accident cover. The cost of this upgrade is as follows:

Junior Drivers

**S**35

Junior Mechanics

\$20

Put simply, this covers a junior driver or mechanic with senior driver or mechanic personal accident cover.

#### 8. Licence Upgrades and Replacement Licences

Licence upgrades and replacement licences will incur a cost of \$10 per licence to cover the cost of producing an additional licence.

### 9. One-Day Licence Policy

The price for a one-day licence (personal accident cover inclusive) is \$40.

Drivers are only permitted one (1) one day licence per season. The primary purpose of a One Day Licence is for non-regular drivers such as celebrities, demo-derby drivers, or for new drivers to test a car. This has in the past been abused by drivers who renew their licence late in the season and do not wish to purchase a full licence or obtain a medical.

If a driver requires a second One Day Licence, they will be required to purchase a full licence, paying for the upgrade only. (to the difference)

All applicants for FAS Personal Accident Insurance cover must supply a passport sized photograph to the NASR National Office before the FAS Card will be processed and returned.

#### 13. Top-up Personal Accident cover

For those participants who wish to top-up their Personal Accident cover to more than 5500 per week for weekly benefits to a maximum of \$1100 per week, \$100 units are available for \$30 per unit.
