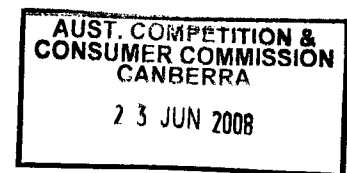
We refer to the above Authorisation which was granted on 17 December 2003.
